1. Repair and Maintenance for Small Membership Hawaiian Churches Committee: Kealahou Alika's report was questioned by Mike Warren regarding Kalapana Maunakea First Hawaiian Church's grant application for the installation of railings to steps leading to the church from their makai parking lot. Grant was denied because it was incomplete. A letter dated December 15, 2015 was sent to the moderator of the church outlining this concern and a request that documentation be provided. Projects over \$5,000 require a bid from a licensed contractor with details on cost of materials. There was no Contractor's bid. No response was received. After lengthy discussion, the chair offered to review the matter on receipt of a complete, amended Grant application that addresses the committee's concern. (On June 30, 2016, the end of FY2015-2016, monies not expended will lapse.)

The Committee Chair submitted a booklet he had prepared that included a comprehensive written report of awards under the Repair & Maintenance of small Hawaiian churches program, a listing of grant awardees, photos of projects undertaken. Report was received and placed on file by consensus.

Preface

A meeting of the SCHCC Committee Repair & Maintenance of Small Membership Hawaiian Churches was held on January 17, 2017 at Kaumakapili Church, Pālama, Oʻahu. The agenda included the following:

- 1. Update on Kaulanapueo Congregational Church, Huelo, Maui
- 2. Hawai'i Conference Foundation/Hawai'i Conference 2018 Budget
- 3. Review of 2017 Applications

Kaulanapueo Congregational Church

A letter received from Janet Akau on January 3, 2017. The repairs to the church windows was completed in November 2016. A grant was approved in 2015 for the work that was delayed by inclement weather. Photographs of the completed work were provided.

2018 Budget

The Board of Directors of the SCHCC agreed that a recommendation be made to the Hawai'i Conference Foundation and the Hawai'i Conference – United Church of Christ for an increase in the budget line item of the 2018 Budget. A request will be made that the line item for the "repair and maintenance of small membership churches" be increased to \$75,000.00.

The request was made based on the ongoing needs of the churches.

Review of Applications

- Total number of members
- Average worship attendance
- Church budget
- Previous SCHCC grants received by the applicant

SCHCC Committee on the Repair and Maintenance of Small Membership Hawaiian Churches 2017 ANNUAL REPORT 2nd of 4 pages

Priorities Considered

Priority for consideration was based on the following:

- 1. Churches with titles and deeds held by the Hawai'i Conference Foundation
- 2. Churches requesting assistance for repair and maintenance of ADA-related projects or sewer projects.
- 3. Churches whose own contribution to their respective projects totaled at least 30% or more of the cost.
- 4. Churches whose projects were for repair to existing buildings.
- 5. Churches whose projects were for maintenance purposes.
- 6. Churches whose projects will require much more extensive work.

2017 ANNUAL REPORT

Aloha e na hoahanau me na hoaloha,

The "William Kahuakai Keliihoomalu Scholarship Fund" was established as a memorial Scholarship in 1979, following the passing of Licentiate Kahu, William K. Keliihoomalu. The fund was started with a monetary gift of \$25.00 by Mrs. Ada Larrison, a friend of the family, and continued growing with support from members of the Keliihoomalu 'Ohana, Kalapana Maunakea Congregational Church, and many friends. She requested that this gift be placed in a Custodial Account with the Hawaii Conference Foundation, for the purpose of providing financial aid for seminary, postgraduate and continuing education expenses. When the fund grew to the amount of \$500.00, the State Council of Hawaiian Congregational Churches was appointed Custodian of this Scholarship fund. The State Council of Hawaiian Congregational Churches turned the funds over to the Hawaii Conference Foundation to be invested, setting a goal of reaching the amount of \$5,000.00, with the intention of using the earned interest income towards the granting of scholarships, for the purpose stated. If no applications are received for funding, the monies will remain in the account to continue earning interest.

KCHCC is a member of the State Council of Hawaiian Congregational Churches (SCHCC). SCHCC, an advocate for Hawaiian Churches of the Hawai'i Conference of the United Church of Christ (HCUCC), looks to the interest of the Hawaiian Churches by keeping the Conference aware of their concerns and needs as the Conference changes in complexion.

There are six (6) member churches: Three with full time pastors. Three without pastors who are blessed with committed lay leadership.

1. Hanapepe Hawaiian Congregational Church: Pastor – none.

Ka'ahumanu Congregational Church

Kahu Wayne Higa continues to lead Ka`ahumanu Congregational Church as they renovate the sanctuary. The pews were stripped and given a natural stain. Arlene Pi`ihana is a Member in Discernment seeking ordination. Services begin at 9 AM.

Kahakuloa Hawaiian Church

The small congregation continues to seek funds to repair the sanctuary. Sun, wind, rain, and sea salt have compromised the building, which is dear to the community. In April, Richard Ho`opi`i and Willie K performed at a fundraiser on Easter weekend. In June, there is the annual Marathon fundraiser. Please keep Kahakuloa in your prayers.

Keawala'i Congregational Church

Reverend Kealahou Alika has led this congregation for almost 2 decades. Church services are: 7:30 AM and 10:00 AM. The congregation promotes involvement in the community of faith. The Outreach Ministry reaches many community groups.

Keolahou Congregational Hawaiian Church

Keolahou Congregational Hawaiian Church of north Kihei, Maui continues to offer divine worship to an average of 60-70 worshipers each Sunday morning. Communion is served the first Sunday of each month by a retired Presbyterian minister. A variety of local ministers and laypersons rotate the responsibility of preaching the Word. Despite the small membership (23) and the lack of a Settled or Interim Minister the church provides a quality worship experience that draws heavily on Hawaiian culture and traditions including Oli, Mele, Hula and Ukulele. KCHC is committed to perpetuating the Hawaiian culture in partnership with a local Halau by co-sponsoring Sunday afternoon hula lessons and a Thursday night Ukulele jam.

Our mission includes supplementing the needs of the residents of south Maui by providing a weekly food distribution through our Food Pantry Ministry. Several local churches also support the Food Pantry through donations of food and cash. In addition, church volunteers provide a monthly potluck dinner at the Wailuku Homeless Shelter. Our mission also includes the maintenance and updating of church facilities and offer them to local self-help groups for their meetings.

Lāhuiokalani Kā'anapali Congregational Church:

A core group 18 attend church each Sunday but the numbers swell as returning visitors fill our pews. In the last year, our worship team has added more singing prior to the service. It prepares us

for worship. Service each Sunday is at 10 AM. Our on-going project is to build a Hale Ai and provide parking, which is very limited in an area with many condominiums.

Pā'ia Hawaiian Protestant Church

Pā'ia Hawaiian Protestant Church holds worship services with Kahu Roy Newton, whom our membership accepts as our Kahu. Service is at 11 AM.

There are two members that our church are recommending to be in discernment. Exploring this path through AHEC's Church and Ministry is pending. And, there is strong leadership in our youth. We are truly blessed.

Our annual Ho'ike, held in November, was well attended by various Churches and Christ-loving groups who shared their love for Christ through worship & scriptures. Christmas Eve Candlelight Services and a Christmas Day Worship Services were held. Easter Sunrise Service is scheduled.

Olowalu Lanakila Hawaiian Church:

The congregation is comprised of family members, who take turns in leading, serving, and providing the weekly message. Service each Sunday is at 9 AM.

In December 2016 Olowalu Lanakila hosted an `Aha Mele led by Maile Baird of Ko'olau Hui'ia Church on Kauai along with her sister, Pualani Muraki, of Lanakila Congregational Church in west Hawaii. This event, sponsored the Hawaiian Affairs Committee, was a very successful mele. Maile shared many songs from Ni`ihau. She said the tradition in Ni`ihau is to sing **each verse** 3 times. She encouraged this tradition, which helped to write the songs in to our hearts! The next Aha Mele will be in July or August 2017.

Waiola Church UCC:

Waiola UCC in Lahaina is in transition as a new kahu is being sought. Interim Kahu Dennis Alger arrived in July 2016 to assist the congregation in tasks of self-understanding prior to starting work with the Transition/Search Committee, which began its work in April 2017.

Outreach opportunities to the community include: "Trunk or Treat" at Halloween; Appreciation for our first responders on Thanksgiving Sunday, where 12 firefighters on three trucks drove to the church; and monthly family-friendly movie nights on the lawn. Na Kia`i o Waine`e, the fine folks who maintain the historic graveyard and perpetuate research and education continue in their efforts (funded, in part by lei sales on Second Friday and other events). Waiola also welcomes many visitors, especially during winter months. Please pray for our congregation during this time of transition. Service each Sunday is at 9 AM.

Our History: The working of God can be first documented in the early history of Haili Congregational Church. First, God used the zeal of Henry Opukahaia, the first Hawaiian convert to Christianity, to inspire New England missionaries to bring the Gospel of Jesus Christ to his native land. Secondly, six months prior to the arrival of the first missionaries at Kailua, Kana, King Kamehameha II (Liholiho) broke the kapu system of pagan worship. Thirdly, with the spiritual vacuum created by the loss of kapu system, response to the gospel was tremendous on the eastern side of the Big Island especially through the peaching of Rev. Titus Coan, one of the missionaries of the early Hila Mission. The Church grew to over 10,000 members with 1705 Hawaiian baptized on one day alone, perhaps the largest church in the world at that time. Our present building is the fifth, dedicated 1859. The first was a huge thatched roof edifice holding 2,000 people near the present Hila Iron Works. The second and third were in the present Kalakaua Park area, and the fourth built on a rise above the present parking lot of the Sack & Save Store. The church continues today in the same Biblical and Christ-centered ministry as when the Royal Family were a part of our congregation. Jesus Christ is the head of the Church and the Bible is our standard in all matters of faith and practice.

Our Purpose: Haili Church is dedicated to the Lord Jesus Christ (UA LA'A NO IEHOVA). The church exists to bring glory to the triune God, promote Christ's work in Hila and to the nations of the world. The church invites you to share in a personal relationship with God by receiving Jesus as your Lord and Savior. To do this, admit to God that you are a sinner and need to be saved. Then believe the Jesus died on the cross for your sins and invite Him into your heart by faith. Now that you have asked Jesus into your life, we want to welcome you into the family of God! If you do not have a church home, we would love to have you as a part of Haili Church. We love to help you grow in your new relationship with Jesus Christ.

All the praises and thanks go to God, for all the work and activities done of this church, which have been carried on and through the efforts of our Kahu, deacons, and board of directors, the praise team and all the fellow members for this entire year of 2016.

There is no change to the Church membership which remains the same at 21. The average worshippers in attendance has been 31, and on Easter morning service with started at 07:30AM 7 8 were in attendance. In Sunday School, there are 11 participants and the average in attendance has been 7.

At our general membership meeting held January IOth, election of officers and the following Sunday, January 17th the installation of officers. Also on January 17th, our church member, Kermit Johnson was considered as a candidate for outreach ministry to the United Church of Christ. Kalaupapa Sunday Anniversary was held on January 31st. Pray for us that the Board of Water Supply and the Powers that be see their kuleana is helping to repair this problem that affects all of us.

Report of the Conference Minister 195th `Aha Pae`aina

Although the assessment process this last year was a major topic in the life of the Hawai`i Conference, the ministry and mission of the Hawai`i Conference continued unabated. The reports of this `Aha Handbook recount many of the ways in which we accomplished God's work together and in partnership. Unmentioned—and equally important—are the many more ways they happen through the quiet and loving labor of each of our churches and individual members.

In this report, I share these highlights and areas of note.

Mission Support

Support from churches and individuals to the ministries of the Hawai'i Conference and the United Church of Christ was extremely strong in 2016.

Our Church's Wider Mission (OCWM), representing church giving, stood at about \$288,000. This was just under the previous year's total, and most notable was the large increase in numbers of Hawaiian churches giving to OCWM and the increase in total giving by Hawaiian churches.

The year-end invitation to give to Friends of the Conference, which is support received from individuals, resulted in a record high of just over \$19,000, which is an over 45% increase above the previous year. We are grateful to these Friends of the Conference whose total giving has increased consistently every year since 2011.

There are many beneficiaries of our solid support, locally and world-wide. A new OCWM brochure/poster helps to explain in pictures and words the impact of our giving. If you need copies, please contact the Conference Office.

Mission Partnerships

The Hawai'i Conference is in a formal mission partnership with two church bodies. Our long-standing partnership with the Micronesian Council United Church of Christ

Our long-standing partnership with the Micronesian Council United Church of Christ (MCUCC) continues the connection first made when missionaries from Hawai'i were sent to Kosrae beginning in 1852. Through this partnership, we participate directly in mission efforts (in cooperation with Wider Church Ministries of the UCC), and we are kept informed of needs of Marshallese and Micronesian churches that are established in Hawai'i and on the U.S. continent. I attend MCUCC meetings annually, including the last, which took place in Kosrae last month.

A more recent partnership is the one established at last year's 'Aha Pae'aina with the South Seoul Presbytery of the Presbyterian Church in the Republic of Korea. In April, the Rev. Curtis Kekuna and I were invited to Seoul to attend the formal recognition on the Korean side by the Presbytery and to lay the groundwork for local church-to-local church partnerships. We are hoping that delegations from local churches in Hawai'i will visit the South Seoul Presbytery this coming fall.

Aloha Kakou,

In October 2016, the State Council of Hawaiian Congregational Churches (SCHCC) held a two (2) days Board of Director's Meeting in West Hawaii, hosted by the West Hawaii Council of Hawaiian Congregational Churches. We had the opportunity to visit and talk story with representatives of Helani, Lanakila, Kahikolu, Pukaana, Hauoli Kamanao, and Kauahaao, member Churches of the West Hawaii Council.

In particular, the history of Henry Opukahaia as shared by Gordon Leslie, at Kahikolu in Napoopoo, and Kahu Pono Debbie Wong Yuen, at the Henry Opukahaia Chapel in Punaluu, was very educational for us. Mahalo to Gordon and Debbie for the valuable information.

The Bicentennial Anniversary of the Mission House Museum will be celebrated in 2020 and we are happy to share that Aunty Aletha Kaohi has been appointed, by the SCHCC Board, to represent the SCHCC on the planning committee. On another "planning" note, the SCHCC will take the lead with the planning of the 2018 Aha Iki for the 196th Aha Pae'aina.

Since the Aha Makua of the 194th Aha Pae'aina, we have come through a season of hate, anger, un-forgiveness and love which was triggered by complaints and concerns raised by a group who were dissatisfied with the Hawaii Conference United Church of Christ (HCUCC). To address the group's concern, a Consultant was hired to conduct interviews with individuals and focus groups, which resulted in an assessment summarized by that Consultant. The Assessment has been made available on-line by the HCUCC.

The Conference Council of the HCUCC, recently approved the appointment of the SCHCC as Custodians of the Katherine and Clay Wery Fund. The SCHCC has begun discussion on the purpose and use of the funds.

The Repair & Maintenance Fund, a line item in the Hawaii Conference Foundation budget, remains at \$40,000.00, after efforts by the SCHCC (as Custodians) to increase that allocation failed.

On a bittersweet note, Kahu Charles Buck has announced his resignation as Conference Minister. On a happier note, his resignation stems from a job promotion offered to his wife Susan, which she accepted. Our best wishes and blessings on a new chapter of their journey.

With the recent notice of Kahu Buck's resignation, an Intentional Interim Search Committee has been formed and Kahu Kealahou Alika will represent the SCHCC on that Committee.

As FY 2016 – 2017 comes to a close, the State Council of Hawaiian Congregational Churches continues advocating on behalf of our Hawaiian Churches of the Hawaii Conference.

STATE COUNCIL OF HAWAIIAN CONGREGATIONAL CHURCHES NEW MEMBERSHIP PROCEDURES

New churches will be formed from time to time, desiring to be *considered for and accepted as* a member of the State Council of Hawaiian Congregational Churches.

The responsibility of recognizing new churches, into the State Council of Hawaiian Congregational Churches, is that of the Island Council.

Pre-requisite for Membership:

- 1) The New Church must be a member of an Association of the Hawaii Conference of the United Church of Christ (i.e. Kauai, Oahu, Tri-Isle (Maui, Moloka'i, Lana'i), Hawai'i or AHEC) who/which embraces Hawaiian cultural practices, including its language, its values and its traditions.
- 2) The New Church shall present a letter seeking membership and its church bylaws to the Island Council within whose bounds it is located.
- An Island Council, having received such a letter and bylaws, from the New Church, shall inquire as to its understanding of the United Church of Christ Polity.
 Membership requires commitment to attend and be an active participant at all Island Council Meetings and events, as well as be up-to-date with the payment of membership dues as required.
- 4) Upon reviewing the required documents and insuring that the New Church candidate understands and is in agreement with the United Church of Christ Polity, the Island Council shall present its recommendation to the State Council of Hawaiian Congregational Churches Board of Directors.
- 5) The State Council of Hawaiian Congregational Churches having received the recommendation of the Island Council shall, at its discretion, vote on membership.
- 6) Upon acceptance, the State Council of Hawaiian Congregational Churches shall conduct a Service of Covenant at its Annual Meeting (the Aha Iki) during the Aha Pae'aina.

Note: If a New Church candidate is not a member of an Association of the Hawaii Conference of the United Church of Christ (i.e. Kauai, Oahu, Tri-Isle (Maui, Moloka'i, Lana'i), Hawai'i or AHEC) but embraces Hawaiian cultural practices, including its language, its values and its traditions, the Island Council may consider Associate Membership status (as outlined in 2, 3, 4 and 5).

THE CONSTITUTION

of the

STATE COUNCIL OF HAWAIIAN CONGREGATIONAL CHURCHES

(Affiliate Organization of the Hawai'i Conference of the United Church of Christ)

PREAMBLE

The State Council of Hawaiian Congregational Churches celebrates and nourishes its biblical roots in the Christian faith, while sustaining the richness of Hawaiian traditions and cultural values. The State Council of Hawaiian Congregational Churches draws together Churches which strive to create opportunities for spiritual growth, leadership and commitment in order to attain a common vision. This vision embraces the nurturing of all people to become instruments for building a better world and community.

ARTICLE I: NAME

This Council shall be known as the State Council of Hawaiian Congregational Churches (hereinafter referred to as the SCHCC), an affiliate organization of the Hawai'i Conference of the United Church of Christ (hereinafter referred to as the HCUCC).

ARTICLE II: PURPOSE

To advocate at all levels of the Hawai'i Conference of the United Church of Christ in the best interest of the Hawaiian churches.

ARTICLE III: POLITY

The SCHCC is a voting member of the HCUCC, as described in the Charter and Bylaws of that organization.

The governance of the SCHCC is vested in its member churches, who shall exercise the right of control in all its affairs subject to the laws of the State of Hawai'i.

ARTICLE IV: MEMBERSHIP

Section 1. Members

- 1. Member churches of the SCHCC; Island Councils, within the HCUCC.
- 2. Member churches embracing Hawaiian cultural practices, including its language, its values and its traditions.
- 3. Member churches shall have a voice in the affairs of the SCHCC and the right to vote as provided in its Bylaws.

Section 2. Delegates

- 1. An active member church shall be entitled to one lay delegate. Churches having more than 200 members shall be entitled to elect one additional lay delegate for each additional 100 members, up to a total of five delegates.
- 2. Each active member church shall also be entitled to elect one youth / young adult delegate, twenty five years of age or younger.
- 3. One authorized minister (ordained, licensed or commissioned) from each active member church.

Section 3. Annual Dues

An active member church is one which is current in payment of their assessed dues. Each member church shall be assessed annual dues. Dues shall be paid and recorded by the Treasurer by January 31.

ARTICLE V: BOARD OF DIRECTORS

The management of the business and affairs of the SCHCC shall be the responsibility of the Board of Directors, which shall consist of the Officers of the SCHCC, one (1) representative from each of the Island Councils and one (1) representative from each Partnership Ministry; such number of directors as outlined in the Bylaws of the SCHCC but under no circumstances less than five (5). Subject to such limit, the member churches may increase or decrease the number of Directors at an Annual Meeting. In the event the Board membership falls below the minimum of five (5), the SCHCC Board of Directors shall make interim appointments for the unexpired term(s). The Directors shall be qualified, nominated, elected, and appointed as provided in the Bylaws. Each Director of the SCHCC shall serve until his or her successor is duly elected.

Section 1. Officers

The Officers of the SCHCC shall be a President, a Vice President, a Secretary, a Treasurer and an Advisor, all of whom shall be members in good standing in an active member church of the SCHCC and with such qualifications, duties and powers as may be provided for in its Bylaws. Except for the Advisor, Officers shall be elected at the Annual Meeting during the 'Aha Iki, or as otherwise provided in Article V above, and preferably with no more than two of the four officers from the same island. The Advisor shall be appointed by the President.

Section 2. Island Councils

There shall be one representative from each of the following Island Councils: Kaua'i, O'ahu, Moloka'i, East Hawai'i, West Hawai'i, Maui, and East Maui Hawaiian Ministry.

Section 3. Partnership

One representative from the Association of Hawaiian Evangelical Churches shall have the privilege of voice and vote.

Any other partnership shall have the privilege of voice only without vote.

ARTICLE VI: AMENDMENTS

This Constitution may be amended by two-thirds (2/3) vote of the delegates of member churches present at the Annual Meeting, provided notices of the proposed amendment(s) shall have been given to each member church at least 30 days prior to the Annual Meeting where voting will take place.

BYLAWS

of the

STATE COUNCIL OF HAWAIIAN CONGREGATIONAL CHURCHES

(Affiliate Organization of the Hawai'i Conference of the United Church of Christ)

ARTICLE I: MEMBERSHIP

Section 1. Members

- 1. Member churches of the State Council of Hawaiian Congregational Churches (hereinafter referred to as the SCHCC), Island Councils, within the Hawai'i Conference of the United Church of Christ (hereinafter referred to as the HCUCC).
- 2. Member churches embracing Hawaiian cultural practices, including its language, its values and its traditions.
- 3. Member churches shall have a voice in the affairs of the SCHCC and the right to vote as provided in Article I; Section 5. Voting Privileges of these Bylaws.

Section 2. Partnerships

- 1. One representative from the Association of Hawaiian Evangelical Churches shall have the privilege of voice and vote.
- 2. One representative from Pūʻā Foundation shall have the privilege of voice only without vote.

Section 3. Delegates

- 1. An active member church shall be entitled to one lay delegate. Churches having more than 200 members shall be entitled to elect one additional lay delegate for each additional 100 members, up to a total of five delegates.
- 2. Each active member church shall also be entitled to elect one youth / young adult delegate, twenty five years of age or younger.
- 3. One authorized minister (ordained, licensed or commissioned) from each active member church.

Section 4. Annual Dues

An active member church is one which is current in payment of their assessed dues. Each member church shall be assessed annual dues as recommended by the Board of Directors and approved at the Annual Meeting. Dues shall be paid and recorded by the Treasurer by January 31. In addition, each member church is required to be in good standing with their respective Island Councils.

Section 5. Voting Privileges

Each member church, lay delegate, youth/young adult delegate and minister as outlined in Article 1, Sections 1 & 2 of these Bylaws shall have voice only in the affairs at the Quarterly Board of Directors (BOD) meeting, and voice with vote at the Annual Meeting.

- 1. An active member church shall be entitled to one voting delegate. Churches having more than 200 members shall be entitled to one additional voting delegate for each additional 100 members, up to a total of five voting delegates.
- 2. Each active member church shall be entitled to a youth/young adult voting delegate.
- 3. One authorized minister from each active member church shall be entitled to a vote.
- 4. SCHCC Officers (Vice President, Secretary, Treasurer and Advisor) and BOD members shall have voting privileges at the quarterly Board of Directors meetings, Special meetings and Annual Meeting.
- 5. SCHCC President shall have voting privileges at the quarterly Board of Directors meetings, Special meetings and Annual Meeting, only in the event of a tie.

ARTICLE II: BOARD OF DIRECTORS

Section 1. Composition of the Board of Directors -

There shall be a Board of Directors consisting of the following:

- 1. The Officers of SCHCC (President, Vice President, Secretary, Treasurer and Advisor);
- 2. One (1) representative from each of the Island Councils (Kaua'i, O'ahu, Moloka'i, East Hawai'i, West Hawai'i, Maui, and East Maui Hawaiian Ministry);
- 3. One (1) representative from the Partnership Ministries (AHEC and Pū'ā Foundation).

Section 2. The purpose of the Board of Directors is to advocate, in the best interest of the Hawaiian churches, at all levels of the HCUCC.

Section 3. Tenure - Each SCHCC Officer shall serve for a term of two (2) years. Each Island Council representative and Partnership Ministry representative shall serve their terms as allowed by their respective bylaws.

ARTICLE III : OFFICERS

The Officers shall be members in good standing within an active member church of the SCHCC. There shall be a President, a Vice President, a Secretary, a Treasurer and an Advisor. The duties of the Officers shall be as follows:

Section 1. President:

- 1. Shall preside at all meetings of the SCHCC Board of Directors and the Executive Committee.
- 2. Shall be responsible for the administration of business affairs.
- 3. Shall prepare an Annual Report
- 4. May create and appoint Task Forces and Special Committees as needed, with the Board of Directors approval.
- 5. Shall be an ex-officio member of all Standing Committees, except the Nominations Committee, with voice only and no vote.
- 6. Shall represent the SCHCC on the HCUCC Council.

Section 2. Vice President:

- 1. Shall be the presiding officer in the absence of the President.
- 2. Shall assume the presidency in the event the President resigns or is not able to serve.
- 3. Shall chair the Committee for Repair and Maintenance of Small Membership Hawaiian Churches.
- 4. Shall prepare an Annual Report of the Committee for Repair and Maintenance of Small Membership Hawaiian Churches.

Section 3. Secretary:

- 1. Shall record accurate minutes of all meetings of the Board of Directors and the Executive Committee, including Special meetings pertaining to the business of SCHCC, as well as the Annual meeting.
- 2. Shall be responsible for compiling and preparing reports submitted by all Officers, the Advisor, Island Council Presidents, Committee Chairs and Partnership Ministries for the Annual Meeting handbook.
- 3. Shall provide a sign-in sheet for all meetings of the Board of Directors and the Executive Committee as well as for all delegates attending the Annual Meeting.
- 4. Shall include a copy of the previous year's Annual Meeting minutes in the current year Annual Meeting handbook.
- 5. Shall send Board of Directors and Special Meeting minutes to the members of the Board of Directors, 2 weeks prior to each scheduled Board meeting, with the agenda for the scheduled meeting.
- 6. Shall send Executive Committee meeting minutes to the Executive Committee, 2 weeks after the meeting.
- 7. Shall record any corrections and additions to all meeting minutes, after approval by the Board.
- 8. Shall issue notices of meetings one (1) month prior to each meeting by written notice, via email. (If no email access, then by U.S. Mail)

Section 4. Treasurer:

- 1. Shall receive and deposit all funds in an accredited financial institution approved by the Board of Directors of this Council.
- 2. Shall keep an accurate accounting of all funds received and disbursed and shall give a detailed report of all accounts at each Board of Directors meeting.
- 3. Shall prepare a financial report for the Annual Meeting.
- 4. Shall keep an accurate record of all member churches current with payment of their dues and notify the Secretary of those member churches in arrears by March 01 of each year prior to the Annual Meeting.
- 5. Shall make all payments by check. There shall be two signatures on the checks, those of the Treasurer and the President or Secretary.

Section 5. Advisor:

- 1. Shall have thorough understanding and experience of the SCHCC.
- 2. Shall advise the Board of Directors in matters of function, policy, church polity, past practices and historical background.
- 3. Shall prepare a report for each board meeting and the Annual Meeting.
- 4. Shall be appointed by the President and shall serve a term coincident with the President's.

ARTICLE IV: TERM OF OFFICE

The officers of the SCHCC shall be elected for a term of two (2) years. They may not serve in the same office for more than two (2) consecutive terms.

The President shall have the authority, with approval by the Board of Directors, to fill any vacancy in the officer positions for an interim period until the next scheduled election.

ARTICLE V: REMOVAL OF OFFICER

Any officer may be removed by a majority vote of the membership whenever the best interest of the Hawaiian Churches and this Council is not served.

ARTICLE VI: EXECUTIVE COMMITTEE

Section 1.

The Executive Committee shall be comprised of the Officers of the SCHCC. The Executive Committee is charged with the following responsibilities:

- 1. Prepare the agenda for all meetings
- 2. Establish the date and time of all meetings
- 3. Be an advocate for all member churches
- 4. Prepare the Annual Budget

ARTICLE VII: MEETINGS

All meetings shall be opened and closed with pule 'ohana.

Section 1. Annual Meeting

The Annual Meeting will be held during the 'Aha Iki at the 'Aha Pae'aina in June. During the Annual Meeting of the SCHCC, time shall be provided for business, spiritual and cultural awareness concerns.

The majority vote shall be the preferred method for deciding matters that are before the member churches at the Annual Meeting.

Section 2. Board of Directors Meetings Schedule

The SCHCC Board of Directors shall meet in July, October, January and April. All Board of Directors meetings are open to member churches, with the privilege of voice only, without vote.

Section 3. Special Meetings

Special meetings may be called by the Board of Directors, by written notice sent out electronically or by U.S. Mail fourteen (14) days in advance to active member churches, stating time, place and purpose of the special meeting.

ARTICLE VIII: STANDING COMMITTEES

Section 1. Standing Committees

The Standing Committees shall be:

- (1) Repair and Maintenance of Small Membership Hawaiian Churches.
- (2) Endowment / Scholarship.

The Committee chairpersons shall be members of the Board of Directors and will be appointed by the Board of Directors. The Chairperson of the Committee for Repair and Maintenance of Small Membership Hawaiian Churches, shall be the Vice President. The Chairperson of the Endowment / Scholarship Standing Committee will maintain the autonomy of the independently funded programs reporting through the SCHCC. (Endowment / Scholarship Standing Committees may include Kahu Richard Wong Endowment Fund, William Keliihoomalu Scholarship and others).

Section 2. Task Forces and Special Committees:

The President may establish Task Forces and Special Committees to address special issues and needs with majority approval votes from the Board of Directors.

ARTICLE IX: INDEMNIFICATION AND INSURANCE

Section 1.

The SCHCC shall indemnify each person who was or is a party or is threatened to be made a party to any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative, or investigative (other than an action by or in the right of the SCHCC) if that person is or was a director, officer or agent (hereinafter to include volunteers) of the SCHCC, against expenses (including attorneys' fees), judgments, fines, settlements, and other amounts actually and reasonably incurred in connection with the proceeding if the person acted in good faith and in a matter the person reasonably believed to be in or not opposed to the best interests of the SCHCC, and, with respect to any criminal proceedings, had no reasonable cause to believe the conduct of the person was unlawful. The termination of any proceedings by judgment, order, settlement, conviction or upon plea of nolo contendere or its equivalent, shall not, of itself, create a presumption that the person did not act in good faith and in a manner which the person reasonably believed to be in or not opposed to the best interests of the SCHCC and, with respect to any criminal action or proceeding, had reasonable cause to believe that other person's conduct was unlawful.

Section 2.

The SCHCC shall indemnify each person who was or is party or is to be made a party to any threatened, pending or completed action or suit in the right of the SCHCC to procure a judgment in its favor because that person is or was a director, officer, or agent of the SCHCC against expenses (including attorney's fees) actually and reasonably incurred by the person in connection with the defense of settlement of the action if the person acted in good faith and in a matter the person reasonably believed to be in or not opposed to the best interest of the SCHCC, except that no indemnification shall be made in respect of any claim, issue, or matter as to which the person shall have been adjudged to be liable for negligence or misconduct in the performance of the person's duty to the SCHCC unless and only to the extent that the court in which the action or suit was brought shall determine upon application that, despite the adjudication of liability but in view of all the circumstances of the case, the person is fairly and reasonably entitled to indemnity for such expenses as the court deems proper.

Section 3.

To the extent that a director, officer, or agent of the SCHCC has been successful on the merits or otherwise in defending any proceeding referred to in Sections 1 or 2 of this Article, or in defense of any claim, issue or matter therein, such person shall be indemnified by the SCHCC against expenses (including attorney's fees) actually and reasonably incurred by such person in connection therewith.

Section 4.

Any indemnification under Sections 1 and 2 of this Article (unless ordered by a Court) shall be made by the SCHCC only if authorized in the specific case upon determination that indemnification of the director, officer or agent is proper in the circumstances

because the director, officer, or agent has met the applicable standard of conduct set forth in Sections 1 or 2.. The determination shall be made (a) by the Board of Directors by a majority vote of quorum consisting of directors who were not parties to the proceeding, or (b) if a quorum is not obtainable, or even, if obtainable if a quorum of disinterested directors so directs, by the independent legal counsel in a written opinion to the SCHCC or (c) by the court in which the proceeding is or was pending upon application made by the SCHCC or the director, officer, or agent or the attorney or other person rendering services in connection with the defense, whether or not the application by the director, officer, agent, attorney or other person opposed by the SCHCC.

Section 5.

Expenses incurred in defending any proceeding may be paid by the SCHCC in advance of the final disposition of the proceeding as authorized by the Board of Directors in a particular case upon receipt of an undertaking by or on behalf of the director, officer, or agent to repay such amount unless it shall ultimately be determined that the director, officer or agent entitled to be indemnified by the SCHCC as authorized in this article.

Section 6.

The indemnification provided by this Article shall not be deemed exclusive of any other rights to which those indemnified may be entitled and shall continue as to a person who has ceased to be a director, officer, or agent and shall insure to the benefit of the heirs and personal representatives of such a person.

Section 7.

The SCHCC shall have the power to purchase and maintain insurance on behalf of any director, officer, or agent of the SCHCC against any liability asserted against or incurred by the director, officer, or agent in any such capacity or arising out of the director's, officer's or agent's status as such, whether or not the SCHCC would have the power to indemnify the director, officer, or agent against liability under this Article.

ARTICLE X: QUORUM

Section 1. Annual Meeting

The Quorum for the Annual Meeting shall consist of a majority of active member churches present.

Section 2. Board of Directors

The presence of two-thirds (2/3) of the Board of Directors will constitute a quorum.

ARTICLE XI: PARLIAMENTARY PROCEDURES

When questions of Parliamentary Procedures are raised, particularly on issues that are contested, the current edition of Robert's Rules of Order shall be consulted to resolve any impasse.

ARTICLE XII: AMENDMENTS

These Bylaws may be amended by two-thirds (2/3) vote of the delegates of member churches at the Annual Meeting, provided notices of the proposed amendment(s) shall have been given to each member church at least 30 days prior to the Annual Meeting where voting will take place.

STATE COUNCIL OF HAWAIIAN CONGREGATIONAL CHURCHES (SCHCC)

FUND FOR REPAIR & MAINTENANCE OF SMALL MEMBERSHIP HAWAIIAN CHURCHES

Application Information

Funding for the Repair & Maintenance of Small Membership Hawaiian Churches is included by the Hawaii Conference Foundation (HCF) in its annual budget. Monies so allocated must be spent within the fiscal year for which it is approved.

The SCHCC has been given the responsibility for administering the funds, but in truth, we must all be partners in seeking the means by which needed repairs can be made. The underlying philosophy of the HCF and SCHCC is to help Hawaiian churches help themselves by sharing in the efforts by church members to raise funds (*i.e.* fundraising, solicitation of gifts, tithing goals, etc.)

More often than not, requests from Hawaiian churches exceed the amount allocated in the budget, not surprisingly, given the age of some of the structures and facilities. The task of reviewing requests and determining which are funded and by what amount, falls to the SCHCC.

In so doing the SCHCC Committee for the Repair & Maintenance of Small Membership Hawaiian Churches (hereinafter referred to as R&M Committee) must take into account a number of considerations including the following:

- The Need for the Project

Is the repair or maintenance critical? How would it affect the mission of the church? What might happen if it were not done? Is it time-critical? Must the work be done within a certain time-frame? What is the church's participation (*i.e.* sharing the cost; providing in-kind services; a combination of both?)

- Priority Consideration

If there are not enough funds to grant all requests, support must first be given to the churches whose deed is held by the HCF. The HCF, as Trustee, has a fiduciary responsibility which carries a legal obligation to support those churches.

In cases where a church that holds its own deed is faced with unusual extenuating circumstances that cannot be addressed because of the preferential obligation imposed by the Trust, SCHCC may suggest an alternative that avoids any conflict.

Applications for the repair and maintenance of septic systems and handicapped accessibility are also priorities of the fund. The first would be in compliance with the Environmental Protection Agency (EPA) and the State Department of Health.

The second would be in compliance with the Americans With Disabilities Act (ADA).

- Scope of Work

The fund is available to cover the cost of the repair and maintenance to existing structures on church premises including the *hale pule* (church building), *hale 'āina* (social/fellowship hall) and *hale ke 'ena* (office building). The scope of work may include the repair and maintenance of windows, doors, floors, and roofs as well as painting, electrical, plumbing and fumigation work.

What the fund does not cover is the cost for sound systems, computer systems, carpeting, air conditioning, fans, appliances and furnishings as well as parking lots, landscaping, gates and fences.

- Reimbursements

Reimbursements for complete projects will not be considered unless, at the discretion of the R&M Committee, compelling and justifiable reasons dictate otherwise.

- Completeness of Application

All applicable items must be completed including the duly-signed minutes of the meetings of both the Member Church and its respective Island Council. The minutes of the meeting of the church's governing body (*i.e.* Congregation, Church Council) must include the type of project the funds are being requested for; the estimated cost of materials, labor and skills to be hired; a clear showing of the total amount to be contributed by the Member Church in cash, in-kind services, or a combination of both and the action taken.

Projects costing more than \$5,000 must be supported by a Licensed Contractor's estimate.

- Discerning Need

Member Churches are encouraged to discern what is needed most. The work of reviewing and acting upon requests for assistance presents the SCHCC, through the work of the R&M Committee, with a challenge and an opportunity to be in partnership with our member churches.

There are no hard and fast rules. There is no checklist.

However, there are guidelines governing the work of the R&M Committee. The R&M Committee seeks to do its work prayerfully and thoughtfully relying upon the Holy Spirit for wisdom and guidance.

Reviewing the Application

1. Member Church forwards the completed Application Form, with the minutes of the meeting of the church's governing body (*i.e.* Congregation, Church Council) approving the submission of the application to the Island Council President.

Please provide the original application plus 2 additional sets of the application (single-sided copies only) and minutes (double-sided recommended).

2. Upon approval by its Island Council, the Island Council President will forward the application form of the Member Church to the Chairperson of the R&M Committee. The Island Council will provide the minutes of the meeting approving the submission of the application to the R&M Committee.

All applications are due by December 31st.

- 2. At the first scheduled meeting of the SCHCC Board of Directors following the December 31st deadline, the R&M Committee shall present its recommendation to the Board.
 - Whether an application is approved or denied, the Chairperson of the R&M Committee will inform the Member Church of the Board's decision by written notice or via email.
- 4. Upon approval by the SCHCC Board of Directors, the Chairperson of the R&M Committee shall inform the Executive Director of the HCF, in writing, of the name of the church and the amount of the approved grants. The Chairperson of the R&M Committee shall provide the HCF with the approved applications and the minutes of the SCHCC Board of Director's meeting in which the approval action was taken.
- 5. Upon completion of its project, the Member Church shall submit a written report to the R&M Committee, preferably with photographs if available. At that time the account will be closed.
- 6. Any unused funds shall be returned to the SCHCC. Unused funds may not be applied to other projects.

If new projects are considered, churches must submit a new application.

State Council of Hawaiian Congregational Churches (Hawaii Conference Foundation) Kahu Richard W Wong Endowment Fund

On June 25, 1990, Reverend Richard W Wong, Pastor Emeritus of Kaumakapili Church, took a bold step to support Hawaiian churches. On that day, he penned a letter to James Richards of the Hawaii Conference Foundation with the intention of establishing an endowment fund to *kōkua* Hawaiian churches. He transferred all his shares of stock from his investment portfolio to establish the *Kahu Richard W Wong Endowment Fund*.

The purpose of this fund is to assist member churches of the State Council of Hawaiian Congregational Churches with educational, missional, evangelistic, personnel, and building needs, from the earned interest income.

Outreach ministries are given priority over building requests. Churches needing repair and maintenance are encouraged to submit applications to the *Repair and Maintenance* of *Small Membership Hawaiian Churches Committee*.

The State Council of Hawaiian Congregational Churches was given the responsibility for the administration of this fund. The President, of the Board of Directors for State Council of Hawaiian Congregational Churches, appoints a chairperson for this committee.

PROCEDURES FOR APPLICANT: Complete and sign the application, submit the original plus 4 copies of the application to Island Council President. Attach the signed original plus 4 copies of the Church's Minutes, showing the Action taken for the Grant Request, with the applications. Scholarship Policy

Background: The William Kahuaka'i Keli'iho'omalu Scholarship Fund was launched following the passing of Licentiate Kahu, William K. Keli'iho'omalu. Kahu Keli'iho'omalu served as a member deacon of Kawaiaha'o Church for over 20 years. He enrolled in the Lay Pastors School on the Island of Maui and received his certificate as Licensed Minister for the Tri-Isle Mokupuni. Kahu Keli'iho'omalu served at the Paia Hawaiian Protestant Church for a number of years until his retirement. He moved back to his home on the Island of Hawaii in the village of Kalapana, Puna. Upon his death this scholarship was established by a gift from Mrs. Ada Larrison, a friend of the family. She asked that this gift be placed in a Custodial Account with the Hawaii Conference Foundation in the name of "William Kahuaka'i Keli'iho'omalu Scholarship Fund." Over the years' family, friends, and investments raised that fund to \$5,000. It was her request that the principle of \$5,000 remain in the account and the balance of income received would be used for the purpose of providing scholarship to Lay or Ordained ministers for continuing education. If there are no applicants the unused balance would be re-invested in the same account. The custodians of this Fund will be in the care of the State Council of Hawaiian Congregational Churches, or its predecessors.

I. Who Qualifies?

- A) The applicant must be an active member of a church which is a member of the State Council of Hawaiian Congregational Churches.
- B) The applicant must be enrolled in a Licensed Minister School or an accredited Seminary approved by the Scholarship Committee.

II. How to apply for the scholarship?

- A) The applicant must apply through the local Church of which they are an active member.
- B) Application for the William K. Keli'iho'omalu Scholarship can be acquired from the President of the local Island Councils or through the President of the State Council of Hawaiian Congregational Churches.
- C) The Executive Committee of the State Council of Hawaiian Congregational Churches will review and process all applications on October 15th of each year and forward recommendations to the State Council of Hawaiian Congregational Churches Board of Directors for decision.
- D) When an application has been approved, the awardee will be required to sign a Promissory note.

- III. What are the requirements and stipulations?
 - A) Total Scholarship awarded as follows:
 - 1. Seminary -
 - a) initial 3 years not to exceed \$3,000 per completion of education and not exceed \$250 per semester and \$1,000 per school year.
 - b) development -2 years + not to exceed \$2,000 per completion of education and not to exceed \$1,000 per school year.
 - c) continuing education a sum not to exceed \$1,000 per applicant per three (3) year period.
 - B) The award will be sent to the Seminary or School of Theology by the Treasurer of the State Council of Hawaiian Congregational Churches. In the event that a seminary or School of Theology will not accept the award, it will be sent to the recipient. For Continuing Education recipients, the award will be sent to the applicant.
 - C) The Seminary recipient will be required to send a copy of their transcript for each semester. Continuing Education recipients will be required to send a copy of their expense receipts. Transcripts and expense receipts shall be sent to the:

- D) In the event the applicant does not complete his/her course of study, the award then becomes a loan. The applicant shall repay this loan with no interest attached.
- E) If the applicant is unable to complete his/her course of study, the State Council of Hawaiian Congregational Churches Executive Committee shall be notified immediately. The Executive Committee will then review the individual's situation

and determine whether or not the award becomes a loan.
