## **Hawaii Conference UCC Open Elected Positions for 2015-2016**

### **Vice-Chairperson of the Conference Council**

The Vice Chairperson of the Conference Council shall perform the duties of the Chairperson, in case of that officer's absence or inability to act, and shall assist the Chairperson in his or her responsibilities.

### **Treasurer**

The Treasurer shall have the powers and perform the duties customary and incidental to the office and such other powers and duties as may be assigned by the Conference Council. The Treasurer shall provide regular, periodic statements of the financial operations of the Conference to the Conference Council and a full report to the Aha Pae`aina.

### **At-Large Youth/Young Adult**

Member of a HCUCC church, thirty years of age or younger upon election, serving two-year staggered terms, up to a maximum of two terms, and elected by the Aha Pae`aina.

### **Administration Missional Team Chair**

The Administration Missional Team Chairperson presides at all meetings of the Administration Missional Team and shall be a member of the Conference Council. The major functions of the Administration Missional Team are to ensure clarity of roles and expectations of each component of the bylaws; drafting, recommending, reviewing the Conference annual budget; receiving and reviewing staff with the Personnel Committee as well as related employee policies; receiving and identifying options for resolutions in preparation for the `Aha Pae`aina; overseeing and managing with staff the work of outside consultants.

### **Formation Missional Team Chair**

The Formation Missional Team Chairperson presides at all meetings of the Formation Missional Team and shall be a member of the Conference Council. The Formation Missional Team works to develop programs for the Conference, youth, congregations and clergy that provide opportunities that will change people's lives, grow in faith, develop one's sense of call and strengthen the church to be effective UCC witnesses in the community and Hawaii.

### **Nominating Committee At-Large Member**

There shall be a Nominating Committee, which shall be a Standing Committee of the Conference accountable to the Conference Council. The Nominating Committee shall consist of six (6) members, one from each Association, and one At-Large Member. Each member shall serve a term of two (2) years, staggered into two (2) classes. The At-Large member of the Committee shall be nominated by the Conference Council and elected by the `Aha Pae`aina. Members can serve no more than two (2) full consecutive terms at any one time.
