Balance Sheet: As of June 30, 2020

Report shows the Bank of Hawaii Checking Account Balance \$110,689.64. This is separated into three categories: General \$46,393.62, Program \$51,688.33 and Scholarships \$12,569.98. Program Checking is used for the Na Lima 5 E Grants and Scholarship Checking for Kahu. The General Checking is used for all other expenses.

Total Assets: \$2,282,679.67

**Liabilities & Equity: \$1,074.12 In most cases AHEC has no liabilities or debit to creditors; balances set aside to use until end of fiscal year. Total Assets and Total Equity must equal.

Budget Vs Actual Operating Fund (Summary): Report shows the Income and Expense of AHEC. The date is generated by the beginning of the fiscal year July 2019 through June 2020. The report is divided into two sections. Income (Top) and Expense (Bottom) and into three columns. First column is the actual monies received or expensed out. Column two is the 2019-2020 budget projection. Column three shows the variance or difference of budget projected. Note: Negative numbers in variance column. Income (Top) means haven't reach budget goal. Expense (Bottom) means underspent budget.

Luna Hoomalu 2020 Annual Report

Ano'ai me ke aloha ia Iesu,

October 2020

It brings me a great pleasure to share with you another years' report as the acting Luna Hoomalu for the Association of Hawaiian Evangelical Churches (AHEC). Honestly, though I am a full-time seminary student, government official and mother, I did not hesitate in taking on the position as the Luna Hoomalu Hope. My duties included only two items; preside in the event that the Luna Hoomalu is absent and to fulfill my term limit. However, our Heavenly Father had other plans. I was made to act as the Luna Hoomalu in December 2018. It has been about two years of serving in this capacity and I would not have it any other way. I have been able to learn swiftly and take on the actions that were necessary to keep our AHEC advancing.

AHEC, was formulated in 1994 through the United Church of Christ (UCC)-Apology to the Native Hawaiian population for participating in the illegal overthrow of the Hawaiian Kingdom. This action called for the UCC-Redress funds that established our association in representation to the Native Hawaiian population. Our faith in Ke Akua has persevered throughout our history into the present day. We give all glory to Him, our Heavenly Father and am truly blessed to be His Kanaka 'Oiwi. According to our non-profit Articles of Incorporation under Section 415B-34, Hawaii Revised Statutes (HRS) our AHEC purpose is described in: ARTICLE II-Purpose, the purpose of this Association shall be:

- 2.1 To affirm our Hawaiian Evangelical, biblical roots;
- 2.2 To express our Christian faith through Hawaiian cultural forms, including Hawaiian values, traditions, language, and spirituality.
- 2.3 To authorize and confirm standing of churches and standing of Na Kahu (ministers); and
- 2.4 To transact any and all lawful activities for which nonprofit corporations may be incorporated under Chapter 415B, Hawaii Revised Statutes.

As the acting Luna Hoomalu, the essence that I brought forth in Article II revolved around all four (4) of the items listed above. In my historical research of our Association I have affirmed our Hawaiian Evangelical journey and aim to remain driven in the direction of our Biblical roots to our Heavenly Father. The vitality of our Hawaiian Churches has been unique coming from the ability to express our values and traditions in our own Hawaiian language and liturgy. Upholding our truly rare in the reverence that is professed when we all come together and incorporate His 'Aloha for us. We are all joined together as His standing in His authority and confirming standings to our Hale Pule and Na Kahu. I am truly blessed to be called as an AHEC Member in Discernment (MID), as it has been such a divine educational journey to attend seminary while serving you all. I have grasped a tremendous amount of knowledge in such a short period of time. By His will I am able to apply these

learnings into my service to AHEC. I hope to encourage everyone through enrichment with evangelism evolving as servants perpetuating justice and peace for our Hawaiian people and the people whom have called Hawaii home.

Our current AHEC Bylaws describes the duties of the Luna Hoomalu to include:

- **5.1.2.1** -Shall preside at meetings of the Association, the Executive Committee, the Board of Directors, and the 'Aha Na Kai 'Ewalu;
- **5.1.2.2** -In consultation with the Association officers, shall propose the direction for the Association to the Board of Directors for its approval, and shall make an annual report to the Board of Directors and to the 'Aha Na Kai 'Ewalu;
- **5.1.2.3** -Shall be an ex-officio member of all committees except the Nominating Committee and except where provisions to the contrary may be stated in these Bylaws;
- **5.1.2.4** -May be elected for two (2) consecutive terms totaling four (4) years, and may be elected to another term if one (1) year has elapsed from the time that the person ended the prior term;
- **5.1.2.5** -Shall represent the Association on the Conference Council of the Hawaii Conference UCC;
- **5.1.2.6** -Shall execute all contracts and other documents as ordered by the Association or Board of Directors; and
- **5.1.2.7** -Shall in alternating terms be a Kahu and a layperson.
- **5.1.2.8** -After extensive searching, in the event an eligible nominee is not available, then a nominee from the category may be presented.

Kahu Wendell B.K. Davis Papa Makua Report – Aha Pae'aina – October 2020

"Trust in the Lord with all your heart; do not depend on your own understanding. Seek His will in all you do, and He will show you which path to take".

- Proverbs 3:5-6

For generations of years, Native Hawaiians were sailing to the islands long before the Europeans came to the islands. They used their gifts and skills through the elements of wind, sea, and sky to navigate them home. They knew the different stars and the various ocean currents to get them through their voyage and destined shores. They traveled thousands of miles on their wa'a kaulua. They did not have a compass or map, but would seek the constellation of stars to help them navigate at night and on cloudy nights, relied on the winds and currents, counting each wave that slapped the sides of their canoe. When the stars would move due to the rotation of the earth's axis, the North Star would remain constant. This would be their guide. It would be their $h\bar{o}k\bar{u}$ (star) and point of reference. The ho'okele (navigator) would know where each star rose and their direction. Once they solved the directional turns of the stars, they would look up at the stellar night and navigate in a charted path with fixed eyes upon the beautiful map of the heavens.

Where are your eyes fixed today? In the fifteen months as Papa Makua, it has been a journey of both *kai mālie* (calm seas) and *kai 'ino* (rough seas), yet, there is no other place that I'd rather be, than on this "canoe" of the Association of Hawaiian Evangelical Churches. Over time, we have faced challenges and uncertainties that has caused much unrest, yet we continue to paddle together. We remain steadfast in our faith as we trust in our *ho'okele*, Jesus Christ, our Lord and Savior and the $h\bar{o}k\bar{u}$. of Ke Akua. He doesn't always give us directions or provides a full map view so we can see every turn we eventually take, He does give us a glimpse here, or a direction there., but rarely the entire picture. - 2.1 <u>RECOGNITION OF PARTNERSHIP MINISTRIES:</u> The Association, in the event that another organization agrees with the purposes of the Association as stated in the Constitution of this Association, may recognize such an organization as a Partnership Ministry and by a majority vote of the Board of Directors invite such an organization to become an Associate Member of this Association.
- 2.2 ROLE OF PARTNERSHIP MINISTRIES AS MEMBERS Partnership Ministries, which have standing in this Association as recognized under Section 2.1 herein, shall promote the purposes and programs of this Association and cooperate in its mission.

ARTICLE III- MEETINGS OF MEMBERS

- 3.1 <u>'AHA NA KAI 'EWALU (Annual Meeting):</u> The Aha Na Kai 'Ewalu shall be the Annual Meeting of the Association and shall be held in the month of June in conjunction with the 'Aha Pae'aina (the Annual Meeting) of the Hawai'i Conference and prior to the 'Aha Makua (Business Session of the Annual Meeting).
- 3.2 <u>'AHA HALAWAI (Regular Meetings):</u> Two regular meetings shall be held during the months of February and October of each year, with dates to be determined by the Board of Directors.
- 3.3 <u>'AHA KUKA (Ecclesiastical Council Meetings):</u> The Board of Directors shall call an Ecclesiastical Council at the request of a majority of the members of the Committee on Ministry. An Ecclesiastical Council is a meeting of the Association called for the purpose of deciding ordained ministry and state of the churches.

- 3.4 <u>'AHA LA'A (Special Meeting):</u> A Special meeting(s) for fellowship or business of the Association may be called by the Board of Directors at the request of seven (7) or more churches.
- 3.5 PLACE OF MEETINGS: The Board of Directors may designate any place, either within or without the State of Hawai'i, as the place of meeting for any 'Aha Na Kai 'Ewalu, 'Aha Halawai, or 'Aha Kuka called by the Board of Directors. If no designation is made or if an 'Aha La'a be otherwise called, the place of meeting shall be the registered office of the Association in the State of Hawai'i; but, if all of the members shall meet at any time and place, either within or without call or notice, and at such meeting any corporate action may be taken.
- 3.6 KAHEA ANA (Notification) The Board of Directors shall provide written notice of all meetings to the membership at least thirty (30) days prior to the date of the meeting. Said notice shall state the place, day, and hour of the meeting, as well as the purpose or purposes for which the meeting is called, and shall be delivered either personally or by mail.
- KAHU ANA (Representation) Each church shall be represented by two (2) lay 3.7 168 delegates and a youth delegate who is 30 years of age or less at the time of 169 meeting. Those Churches with more than one hundred (100) members shall be 170 entitled to one (1) delegate for each additional fifty (50) or major fraction thereof. 171 The total delegates from any one church shall not exceed seven (7). All Kahu, 172 the Conference Minister of the Hawai'i Conference, members of the Board of 173 Directors, representatives of recognized Partnership Ministries and Chairpersons 174 of Standing Committees shall represent themselves. 175
- 3.8 KE KOHO ANA (Quorum) A quorum for the transaction of business shall be declared when at least one-third (1/3) of the churches in the Association are represented.

ARTICLE IV-BOARD OF DIRECTORS

- 180 **3.9** COMPOSITION OF THE BOARD OF DIRECTORS There shall be a Board of Directors consisting of the following:
 - 3.9.1 The Officers of the Association:

- 3.9.2 One director from O'ahu, Kaua'i, East Maui, West Maui, East Hawai'i, West Hawai'i and Moloka'i, who shall be elected at the Annual Meeting;
 - 3.9.3 One representative from each of the following: State Sunday School Association; Hawai'i Pacific Islander and Asian American Ministries; Pacific Justice and Reconciliation Center; Kamehameha Schools; State Council of Hawaiian Congregational Churches; and Christian Endeavor of Hawaii; and,
- 190 3.9.4 The chairpersons of standing committees.

4.1 TENURE Each Director shall serve for a term of two (2) years and may not serve for more than (3) consecutive terms.

4.2 DUTIES AND RESPONSIBILITIES

- 4.2.1 The purpose of the Board of Directors is to set the direction for the Association in the pursuit of its purpose and mission and to submit to the Association for its approval at the 'Aha Na Kai 'Ewalu the program plans and budget for the attainment of the Association's goals.
- 4.2.2 The Board of Directors shall have the power to fill any vacancies in the Board or its offices, committees, and positions for the interim period until the next scheduled election or appointment by the affirmative vote of the majority of the Board of Directors then serving.
- 4.2.3 The Board of Directors shall issue calls for meetings of the Association.
- 4.2.4 The Board of Directors shall act for the Association between Association meetings and shall carry out those as instructed by the Association.
- 4.2.5 The Board of Directors shall have the power to designate any officer or agent to enter into any contract and deliver any instrument in the name of or on behalf of the Association provided such authority should be confined to specific instances.
- 4.2.6 The Board may endorse to the Conference Nominating Committee a candidate for the Hawai'i General Synod delegation.

4.3 MEETINGS OF THE BOARD

- 4.3.1 Regular Meetings Board shall meet as needed and not less than four (4) times a year. A regular meeting of the Board of Directors shall be held without other notice than these Bylaws. The Board of Directors may provide by resolution the time a and place for holding additional meetings of the Board without other notice than such resolution. The Board may call for meetings and voting by video conferencing or by telephone conferencing, and may permit electronic voting.
- 4.3.2 <u>Special Meetings</u> Special meetings of the Board of Directors may be called by or at the request of the president or any three 3 directors. The person or persons authorized to call special meetings of the Board may fix any place, either within or without the **Pae'āina** Hawai'i, as the place for holding any special meeting of the Board called by them. The discussion and resolution will be limited to the item(s) which the Special Meeting was called for.
- 4.3.3 **Quorum** At all meetings of the Board of Directors a majority of the directors shall be necessary and sufficient to constitute a quorum for the

- transaction of business and the act of a majority of the Directors present at any meeting at which there is a quorum shall be the act of the Board of Directors, excepts as may be otherwise specifically provided by statute or by these Bylaws.
 - 4.3.4 Notice Notice of any special meeting of the Board of Directors shall be given at least five (5) days previously thereto by written notice delivered personally or sent by electronic correspondence to each director at his or her address as shown by the records of the Association. Any director may waive notice of any meeting. The attendance of a director at any meeting shall constitute a waiver of notice of such meeting, except where a director attends a meeting for the express purpose of objecting to the transaction of any business because the meeting is not lawfully called or convened. Neither the business to be transacted at, nor the purpose of, any regular or special meeting of the Board need to be specified in the notice or waiver of notice of such meeting, unless specifically required by law or by these Bylaws.
- **4.4** Compensation and Reimbursement Directors shall not receive any stated salary for their services as such, but by resolution of the Board reasonable expenses of attendance, if any, may be allowed for attendance at such regular or special meeting of the Board. The Board of Directors shall have power in its discretion to contract for and pay to directors rendering unusual or exceptional services to the Association special compensation appropriate to the value of such services.
- **4.5** REMOVAL Any Director may be removed from office at any time with or without cause by the affirmative vote of the majority of votes entitled to vote at any special meeting of the Board of Directors called for such a purpose.
- **4.6 RESIGNATION** Any director may resign at any time by giving written notice of such resignation to the Board of Directors.

ARTICLE V-OFFICERS

OFFICERS: The Officers of this Association shall be members in good standing of a church that is a member of this Association. There shall be a PAPA MAKUA (Association Minister), a LUNA HO'OMALU (President), a LUNA HO'OMALU HOPE (Vice President), a KAKAU 'OLELO (Secretary), and a PU'UKU (Treasure). The duties of the Officers shall be as follows:

5.1.1 The PAPA MAKUA

5.1.1.1 Shall be the spiritual leader of the Association and its chief executive and administrative officer, having general

ARTICLE VII-INDEMNIFICATION OF OFFICERS AND DIRECTORS

7.1 INDEMNIFICATION Any person who is made a party to any action, suit or proceeding, civil, criminal, administrative or investigative, by reason of the fact that such person is or was a director, officer, committee member, or a member of a member Church serving in a position at the request of the Association, shall be indemnified by the Association against the expenses (including amounts paid by way of judgement, and settlement and including attorney's fees) reasonably and necessarily incurred by him or her in connection with the defense of such action, suit, or proceeding, whether or not such defense shall be successful in whole or in part, or in connection with any appeal therein, or any settlement thereof, except in relation to matters as to which it shall be adjudged in such action, suit,

- or proceeding that such person is liable for willful misconduct in the performance of his or her duties.
- 7.2 **AUTHORIZATION** Unless ordered by a court, any indemnification under Section 489 7.1 of this Article shall be made by the Association only if authorized in the 490 specific case upon a determination that indemnification of the director, officer or 491 committee member has met the applicable standard of conduct set forth in 492 Section 7.1. The determination shall be made (a) by the Board of Directors by a 493 494 majority vote of a quorum consisting of Directors who were not parties to the proceeding; or (b) if a quorum is not obtainable, or, even if obtainable if a quorum 495 of disinterested directors so directs, by independent legal counsel in a written 496 497 opinion to the Association; or (c) by a majority vote of the members; or (d) by the court in which the proceeding is or was pending upon application made by the 498 Association or the director or officer or the attorney or other person rendering 499 services in connection with the defense, whether or not he application by the 500 director, officer, attorney, or other person is opposed by this Association. 501
- 7.3 ADVANCE PAYMENTS Expenses incurred in defending any proceeding may be paid by the Association in advance of the final disposition of the proceeding as authorized by the Board of Directors in a particular case upon receipt of an undertaking by or on behalf of the director or officer to repay such amount unless it shall ultimately be determined that the director or officer is entitled to be indemnified by the Association as authorized in this Article VII.
- 7.4 OTHER RIGHTS The indemnification provided by this Article shall not be deemed exclusive of any other rights to which those indemnified may be entitled and shall continue as to a person who has ceased to be a director or officer and shall inure to the benefit of the heirs and personal representatives of such a person.
- 7.5 INSURANCE The Association shall have the power to purchase and maintain insurance on behalf of any director or officer of the Association, against any liability asserted against or incurred by the directors or officer's status as church, whether or not the Association would have the power to indemnify the director or officer against liability under this Article.

(AHEC Land Research Committee)

Mr. Donovan Preza, the foremost authority on the Mahele is leading our *komike* in a tutorial on how to research land. He has invited Dr. Ronald Williams, Jr. as a resource to join us. We meet every Wednesday evening by Zoom for two hours of instruction. So far, we have had two sessions. We are learning that there is much misunderstanding of the Mahele of 1848. It will take us at least a year to understand the Mahele and how to research the land in Hawai`i correctly. What we do know is that Kamehameha III initiated the Mahele to keep the lands in the hands of his people. After our training, we believe we will be able to serve our churches better in defining who owns the lands upon which our churches stand.

The goals of the committee remain the same:

- 1. To research the titles of our AHEC churches to determine who owns the land.
- 2. To research the history of the land of the HCUCC (Hawaii Conference of the United Church of Christ).

Report of the Covenantal Relationship between Kamehameha Schools and the Association of Hawaiian Evangelical Churches-Aha Iki 2020

The Covenantal Relationship between Kamehameha Schools and the Association of Hawaiian Evangelical Churches provides opportunities for nā haumāna to participate in activities with the local churches. These activities have provided opportunities for the students to grow in their faith and character. The churches have been reinvigorated and encouraged to see youth leading worship and practicing servant leadership.

Goals of the Covenantal Relationship

- 1. KS will establish deputation teams which will be available to local churches to lead worship and demonstrate servant leadership. This would demonstrate to the local church that youth can be a contributing member to the worship experience.
- 2. Support the local churches by providing opportunities for the students to demonstrate servant leadership to their church and home communities. KS will assist the student in developing the projects.
- Encourage pastors of the local churches to be a part of our ministry to our children by serving as resources for our Chapels and Christian Education classes.
- 4. KS will make its facilities available for AHEC functions, provided they do not conflict with KS events/functions.
