# Report of the Conference Minister 195th `Aha Pae`aina

Although the assessment process this last year was a major topic in the life of the Hawai`i Conference, the ministry and mission of the Hawai`i Conference continued unabated. The reports of this `Aha Handbook recount many of the ways in which we accomplished God's work together and in partnership. Unmentioned—and equally important—are the many more ways they happen through the quiet and loving labor of each of our churches and individual members.

In this report, I share these highlights and areas of note.

### **Mission Support**

Support from churches and individuals to the ministries of the Hawai'i Conference and the United Church of Christ was extremely strong in 2016.

Our Church's Wider Mission (OCWM), representing church giving, stood at about \$288,000. This was just under the previous year's total, and most notable was the large increase in numbers of Hawaiian churches giving to OCWM and the increase in total giving by Hawaiian churches.

The year-end invitation to give to Friends of the Conference, which is support received from individuals, resulted in a record high of just over \$19,000, which is an over 45% increase above the previous year. We are grateful to these Friends of the Conference whose total giving has increased consistently every year since 2011.

There are many beneficiaries of our solid support, locally and world-wide. A new OCWM brochure/poster helps to explain in pictures and words the impact of our giving. If you need copies, please contact the Conference Office.

## **Mission Partnerships**

The Hawai'i Conference is in a formal mission partnership with two church bodies. Our long-standing partnership with the Micronesian Council United Church of Christ (MCUCC) continues the connection first made when missionaries from Hawai'i were sent to Kosrae beginning in 1852. Through this partnership, we participate directly in mission efforts (in cooperation with Wider Church Ministries of the UCC), and we are kept informed of needs of Marshallese and Micronesian churches that are established in Hawai'i and on the U.S. continent. I attend MCUCC meetings annually, including the last, which took place in Kosrae last month.

A more recent partnership is the one established at last year's 'Aha Pae'aina with the South Seoul Presbytery of the Presbyterian Church in the Republic of Korea. In April, the Rev. Curtis Kekuna and I were invited to Seoul to attend the formal recognition on the Korean side by the Presbytery and to lay the groundwork for local church-to-local church partnerships. We are hoping that delegations from local churches in Hawai'i will visit the South Seoul Presbytery this coming fall.

#### **Conference Staff**

- Lee Henry-Chang, who was my executive assistant, resigned at the end of April to accept an invitation to work with Kupu, a local, non-profit that provides training programs in conservation for youth.
- Sarah Jones, who served as a part-time associate conference minister while pastor of Lana`i Union Church, resigned at the end of May from both positions to become a Pacific Health Ministry chaplain at Wilcox Memorial Hospital on Kaua`i.

#### **Closing Remarks**

On a personal note, my last day in the Conference Office will be Friday, June 23. After that time, I will be with our Hawai'i Conference delegation at General Synod in Baltimore until the close on July 4, at which time I will formally end my service as Conference Minister.

# Report of the Conference Council July 2016 to June 2017

The Conference Council acts for the `Aha Pae`aina in between the annual meetings and also functions as the board of directors for the Hawai`i Conference (Hawai`i Conference Bylaws, Article VII, Section 1).

Following is a summary of actions taken by the Council this last fiscal year:

- Elected Alan Akana as Chair of the Administration Missional Team to fill the remainder of the term vacated by Rod Chamberlain (who relocated to North Carolina).
- Elected Alan Akana as Class A Trustee (two-year term, Class of 2018) and Monty Richards as Class C Trustee (four-year term, Class of 2020) of the Hawai'i Conference Foundation.
- Called Richard Kamanu, Sarah Jones and Kenneth Makuakane as Associate Conference Ministers.
- Engaged KMH LLP as independent auditor for the Hawai'i Conference UCC for the fiscal year ending June 30, 2016.
- Set the dates of June 14-17, 2017, for the 195th 'Aha Pae'aina, to be held at Kamehameha Schools, Maui Campus.
- Appointed Edwin Fong and Janet Fujioka to the Audit Committee, and Gwendolyn Hill to the Personnel Committee.
- Conveyed a reversionary interest to Pearl City Community Church.
- Approved a contract with Northern California Nevada Conference for the provision of bookkeeping services.
- Approved a draw of \$100,000 from investments to cover expenses related to assessment and strategic planning.
- Engaged Alan Oliver as consultant for an assessment study of the Hawai'i Conference.
- Approved the contribution of \$25,000 to the United Church of Christ's "Shaping our Future" campaign benefiting the Office of General Ministries.
- Recommended to the 195th `Aha Pae`aina approval of the resolution, "In Support of a Names Memorial at Kalaupapa."
- Established the Katherine and Clay Wery Trust for Hawaiian Churches with funding by a bequest from the Katherine Wery Estate and the balance of monies in the West O'ahu New Church Fund, and to be administered by the State Council of Hawaiian Congregational Churches.
- Appointed Aletha Kaohi to a three-year term on the Committee on Beneficiaries of the G.N.
   Wilcox Trust and the Distribution Committee of the Elsie H. Wilcox Foundation.
- Received the audited consolidated financial statements for the Hawai'i Conference UCC and Hawai'i Conference Foundation for June 30, 2016 and 2015.
- Engaged Wikoff Combs & Co., LLC, as independent auditor for the fiscal year ending June 30, 2017.

- Received Conference Minister Charles Buck's letter of intent to resign and set his final date for June 4, 2017 (which was later reconsidered and amended to July 4, 2017).
- Received the assessment report from consultant Alan Oliver.
- Created an intentional interim conference minister search committee, whose members would be named by the presidents of the five associations and State Council of Hawaiian Congregational Churches. (Later, an additional seat was created for one Foundation trustee).
- Appointed David Iha as chair of the intentional interim conference minister search committee.
- Approved a draw of \$130,000 from investments to cover expenses related to the cost of a consultant for strategic planning.
- Hired Cynthia Scherr as consultant for a strategic planning process.
- Approved the Minutes of the 194th 'Aha Pae'aina.
- Recommended to the 195<sup>th</sup> 'Aha Pae'aina approval of the Rules of Procedures.
- Recommended to the 195<sup>th</sup> 'Aha Pae'aina approval of the resolution, "Encouraging Immigrant Welcoming Congregations."
- Recommended to the 195<sup>th</sup> 'Aha Pae'aina approval of the budget for fiscal year 2017-18 of the Hawai'i Conference United Church of Christ.

#### ASSOCIATE CONFERENCE MINISTER'S REPORT

Rev. Richard K. Kamanu May 19, 2017

Greetings in the name of our Lord Jesus Christ!

The Aha Pae'aina held in June of 2016 revealed concern and frustration by a few clergy and lay delegates concerning the leadership, mission and ministry of the Conference and Foundation. The Conference Council, hearing the concerns of the delegates, launched a Conference-wide assessment study. After holding interviews with several focus groups and individuals from December 2016 to January 2017, the Rev. Al Oliver handed over a 120-page document, A Special Assessment Study and Report of Findings for the Hawai'i Conference United Church of Christ, in March of this year.

The Rev. Al Oliver wrote, "It has been both a great pleasure and an extreme challenge to conduct this assessment for the Hawai'i Conference United Church of Christ. . . . The challenge has come because the Hawai'i Conference is without a doubt the most complex organization for which I have ever conducted a study."

As a staff member I have the privilege of working with and alongside the Board of Directors of the Conference and Associations, as well as being the staff person assigned to the Church and Ministry Committees for Oahu and Kauai. I've participated in and worked with the Committees in setting up installation services, ecclesiastical councils, ordinations, and worked with exploring congregations seeking membership and standing in the United Church of Christ.

I've been invited as a guest preacher at several of our churches throughout the islands. I've especially valued these times because it allowed me the opportunity to share with the members the work of the Conference and Association. Many of the folk in the pews are unaware of the relationship that their local churches have with the larger church. I explain how their mission support of OCWM extends to programs and ministries of the Conference and the national church.

As the staff person for the Search and Call I work with local church pastoral search committees through the process of seeking a newly called pastor. Along with our Conference Minister and Associate Conference Ministers, we work with local church search committees on our assigned Associations. There are a number of churches in our conference that are presently, or will soon be, seeking a called pastor.

The professional and support staff of the Conference also lend support to missional teams by following through with the planning and implementation of programs created and developed by each of the teams: Administration, Stewardship, Formation, and Justice & Witness.

I would like to thank the Rev. Charles Buck for his leadership and guidance in the last year and a half that I've served as ACM. I thank him for his friendship and his wise counsel. I wish him blessings as he discerns God's next called service.

# ADMINISTRATION LINKING

As an Association, the 'Aha O Nā Mokupuni 'O Maui, Moloka'i a me Lāna'i, (Tri-Isle Association) has tried to act as a 'community of communities' to address the ministry needs of our churches. We expanded our Executive Committee to include persons who serve on Conference Instrumentalities. We wanted to give those who serve on the Conference level a local entity to help them follow through with their conference responsibilities. This 'link' with the Conference helps to shape our TIA lives together, in the service of God. We have at present the following members of the TIA Exec who have Conference responsibilities: Diane Meyer from the Stewardship Missional Teams and Dennis Barger from the Justice and Witness Missional Team. We added Kalani Wong of the Formation Missional Team and we were resourced from the Conference with ACM Sarah Rentzel-Jones. We currently don't have anyone from the TIA on the Administration Missional Team. We have also added Wayne Higa to the Exec who is serving on the Conference's Nominating Committee as well as the TIA Nominations Committee.

#### **HCUCC ASSESMENT**

In response to a request at last year's Aha Pae'aina, the HCUCC engaged in an assessment of ourselves. We used our Winter Aha Makua to host a focus group with the consultant Al Oliver who conducted interviews with individuals within our Mokupuni. #### **CELEBRATION**

This year we celebrated the 150th anniversary of Wailuku Union Church, Kalaiakamanu Hou Congregational Church and the Palapala Ho'omau Church. Maui Evangelical celebrated their 50th anniversary. And the UCC Pohnpei Maui, recognized their standing in the UCC with a recognition service hosted by their church in Haiku.

#### **STANDING**

The Church and Ministry Committee of the Tri-Isle Association recommended continuing education and boundary training requirements for our Authorized Ministers. This was approved at our Winter Mokupuni Meeting. As of this writing we are proposing a name change for the Church and Ministry Committee to become the Committee on Ministry (COM), as so named in our Conference and other UCC entities.

#### **MEMBERS IN DISCERNMENT**

This year we have received four members in discernment: Pualani Akana from Hoolehua, Tim Greathpouse from Iao UCC, Jimmy Aarona who will be recognized as an Authorized Licensed Minister serving Nahiku Congregational Church as well as a supply minister for Kalanikahua Hou and Kaulanapueo, and Jonathan Stockton from Wananalua. Dorothy Lester is in process of

renewing her Licensed Minister standing as she goes to serve Lanai Union as Sarah Rentzel-Jones leaves.

#### **EXPLORING CONGREGATION**

On January 11, 2017 we recognized the UCC Pohnpei Ministry as an "Exploring Congregation" seeking standing in TIA. Their Pastor is Golten Charley.

#### **JUSTICE AND WITNESS**

At our Fall Mokupuni, besides having a presentation from the youth who attended the National Youth Event, we also gathered around round tables to discuss the "Black Lives Matter" issue.

The association held its Fall `Aha Mokupuni meeting on November 19, 2016, at Imiola Congregational Church in Waimea.

We opened with the celebration of worship and communion and message from Imiola's new kahu, David Blevins.

After hearing reports, most of our time was spent with the consultant, Alan Oliver, in the conference assessment process. We had good attendance from church delegates representing both East and West sides of the mokupuni.

## Our Spring `Aha Mokupuni was held on May 20, 2017, at Church of the Holy Cross in Hilo.

Although ten churches were present, our attendance was low because a memorial service was held at the same time for Satsuki Unoki at Hilo Coast United Church of Christ in Honomu. Satsuki was a beloved and respected educator, and a long-time UCC member who was active in the association, conference, Woman's Board, and United Church of Christ. We will miss her very much.

After worship that was led by two of our kahu, Mahina Kaupiko (Hau`oli Kamana`o in Miloli`i) and Dianne Hultmann (Pu`ula in Nanawale), we heard reports of what was happening in the association.

The delegates approved stipends for our two delegates to General Synod in 2017: Rev. Linda Petrucelli (Hilo Coast UCC) and Mrs. Suzanne Smith (Church of the Holy Cross).

We also approved a proposal to have the Hawai'i Conference Office provide administrative and bookkeeping services for the association.

At the end of our time, we gave thanks and appreciation to Conference Minister Charles Buck for his 13 years working with our association and leading the conference, and we wished him well in his future endeavors.

## Report from the President Kauai Association Annual Report – April 2017

The theme was *Looking Back, Moving Forward* based on the Scripture lesson, Philippians 3:12-14. Small group discussions were held and the Youth and Young Adults led a joyous worship.

The Woman's Board of Missions for the Pacific Islands (WBMPI) presented a series of three events, titled "Jesus and Those Bodacious Women." There were heartfelt discussions and hearts ignited for the love of Christ and to do God's work. There will be a fourth event planned in May 2017 to continue the journey of the "Bodacious Women." - October: HCUCC Fall Camp on Oahu—11 youth and 3 chaperones attended. Each youth received a \$100 Scholarship from the KAUCC.
- October: Spaghetti Dinner/Movie/Sleepover at Kapa'a First Hawaiian Church
- November: Youth organized and led the Fall Mokupuni worship, and children met for music, fun, games, stories, and sang a song at Mokupuni.
- March: Youth attended the Spring Retreat at Waineke led by Pastor Olaf and Clint Snyder.
- Upcoming events are a beach clean-up day and picnic and a June Kick-off event.

In March 2017, Kauai Association, Bonnie Shimatsu and the Hanapepe Hawaiian Church hosted a presentation by Ellen Godbey Carson about what it means to be Justice LED (Leaders Engaging and Developing), defined Charity and Justice, and how to do Justice. Ms. Carson provided great activities to do in our churches to discover where our passions lie for doing Justice.

The theme of the Spring Mokupuni 2017 is "Justice = Just Us" and follows the path created by our workshops and our theme to seek Our Legacy and move forward by discerning God's calling.

In addition, the Waineke Lodge committee, the Rev. Glen Frazier (Chair), and the members & volunteers have done an excellent stewardship job of maintaining and upgrading the cabins in Kokee. ## Administration Missional Team of the Hawai`i Conference Report to `Aha Pae`āina 2017

The Administration Missional Team is one of four missional teams working closely with the Conference Council to carry out the mission of the church and to oversee policy, management and staff when the 'Aha Pae'aina (annual Conference meeting) is not in session. The Team met in July 2016 and then regularly throughout the rest of the year and 2017 to plan Council meetings; review staffing, financial, communications and legal issues; and also plan for the 2017 `Aha Pae'āina on Maui. In March 2017, the resignation of Charles Buck as Conference Minister, effective July 4, 2017, caused the Team to shift some of its focus to a smooth transition of leadership and effective communication during the transition.

Some of the more important matters to which the Team attended during the past year are:

- 1. `Aha Pae`āina 2016 Follow-Up
  - A. Evaluation Summary—Overall, the `Aha went well and received positive remarks, including worship, keynoters, workshop and the local church host (Central Union). However, the `Aha did not end in a way that was satisfying, due to the "Resolution: Assessment and Strategic Plan for the Hawai`i Conference, United Church of Christ," that was brought forward and the inability of the delegates to vote on it because of parliamentary issues.
  - B. Budget—Some people expressed interest in receiving more detailed information about the budget; others expressed that they were satisfied with the format as presented.
- 2. The Team recommended that the Conference Council consider the following ways to move forward after discussion regarding `Aha Pae`āina:
  - A. Create a timeline in which the items of the Resolution will be conducted in a timely and realistic manner, consisting of three phases.
    - 1. Phase #1: Assessment, to begin ASAP and finish in late February.
    - 2. Phase #2: Strategic Planning, to begin as soon as Phase 1 is completed.
    - 3. Phase #3: Implementation, to begin as soon as Phase 2 is completed.
  - B. Enlist a paid professional who has successful experience in the phase in which they are assisting. The Team should consider consultants from Hawai`i and the mainland with the intention of recommending to the Council the person who will do the best job.

#### **RESULTS:**

- The Council contracted with the Rev. Al Oliver to conduct a Conference-wide assessment through interviews and focus groups conducted from November 2016 through January 2017.
- An Assessment Report was completed the end of February, presented to the Council on March 4, and emailed to clergy and congregations the following week.
- The Team immediately began compiling a list of names to be considered for consulting for Phase 2, and on April 1 recommended Ms. Cynthia Scherr to be our plenary presenter at `Aha Pae`āina in June 2017 and begin guiding the Council in creating a strategic plan for the Conference. A contract has been signed and Ms. Scherr will begin working as our consultant.
- Due to the findings in the Assessment Report and the resignation of Charles Buck as Conference Minister, the Team and Council decided to seek guidance from Ms. Scherr as to the plenary sessions at the 2017 `Aha Pae`āina, in which she will present,

and begin creating the Strategic Plan after an Intentional Interim Conference Minister arrives.

- The Team recommends that more information about the budget be given at `Aha Pae`āina in 2017, as well as more explanation of how the Foundation budget ties in to the Conference budget (even though the 'Aha does not vote on the Foundation budget).
- 3. Plans were made for the 2017 `Aha Pae`āina to begin with a time of listening to one another, and the bulk of the rest of the time to be spent in worship, study, prayer, discussion and discernment pertaining to our mission as a Conference and the Assessment Report.
- 4. A Joint Budget Committee drafted budgets for the Conference and Foundation.
- 5. The Personnel Committee plans to complete a revised evaluation process for the Conference Minister.

Some of the pending issues (at the time this report was submitted) which are recommended by the Team for follow-up and completion are:

- 1. Complete a Strategic Plan in the fall of 2017 (Phase 2).
- 2. Hire a consultant/coach to implement the Strategic Plan as soon as it is adopted (Phase 3).
- 3. Create an ad hoc committee to review bylaws and rules of procedure (last amended in 2006). One recommendation was received from the parliamentarian at the 2016 `Aha, who suggested that instead of voting each year to give the Council the authority to approve the minutes of the `Aha, we include it in the Rules of Procedure.
- 4. Draft, review, oversee, and, as needed, revise a Conference Communications Plan in order to assure that pertinent and appropriate information from all parties (including Council, Foundation, Associations, Missional Teams, Committees, and Staff) is shared in a timely manner.
- 5. Later in 2017, evaluate bookkeeping support for the Northern California Nevada Conference, which started January 1, 2017, as to its effectiveness and cost.
- 6. Hire an Intentional Interim Conference Minister during the summer of 2017. The term is typically about 18 months long. The Council approves the candidate. The role of the Interim is to provide a "smooth landing strip" for the settled conference minister and will be expected to help discern a Strategic Plan.
- 7. Create a Search Committee for a permanent Conference Minister at the appropriate time and determine a salary range. In the event an Interim is not on board by July 4, the Conference Council can designate a person to serve the as Acting Conference Minister on a month to month basis.

  - 2. Aha Makua—June 16-17, 2017

The results of the Conference assessment and next steps will be the primary focus.

- b. Theme: United in Spirit and Inspired by God's Grace, we welcome all, love all and seek justice for all (newly adopted UCC Mission Statement).
- c. Hawaiian sub-theme: "Holomua Me Ke Ala Pono"
- B. Oahu Church & Ministry is offering a three-session history and polity class the day before the 'Aha.

#### 2. Formation of the Youth

- A. 'Aha Youth Event—informal; to be held on Maui.
- B. Fall Youth Camp will not be happening this year.
- C. Western Regional Youth Event in 2018—Brandon Duran has agreed to be the overall coordinator of a planning team consisting of representatives from each of the eight participating Conferences.

#### 3. Formation of the Congregation

- A. Church Leaders Event: Held on February 25, 2017, at Central Union Church and was a huge success. The classes offered were very helpful and informative for the churches that were present.
- B. *Our Whole Lives* Curriculum—Brandon Duran is tentatively planning a "Train the Trainer" event in September.

#### 4. Formation of the Clergy

A. Communities of Practice:

Eric Anderson will facilitate a Hawaii Island clergy group. Bob Smith started the group on Kauai and already had their first meeting. Richard is looking for a facilitator on Oahu.

The ACMs are part of nationwide Communities of Practice groups.

B. Clergy Retreat: Was held on March 6-8, 2017, at King Kamehameha Hotel in Kailua-Kona. Topic was multiple religious identity and belonging, with Karen Georgia Thompson as the keynoter.

C. Boundary Training: Elizabeth Dilley held a boundary training on Oahu on January 18, 2017, at the Conference Office. Gary Augustin is willing to do boundary training on neighbor islands. Richard Kamanu will coordinate possible dates for the neighbor island clergy.

Our next meeting will be held on August 11, 2017.

#### **Justice and Witness Missional Team 2016-2017 Report**

Micah 6:8: "And what does the LORD require of you? To act justly and to love mercy and to walk humbly with your God."

Justice and Witness (J & W) team members: Kenneth Makuakane, Dennis Barger, Bonnie Shimatsu, Linda Rich, Keoki Kiwaha, Suzanne Smith (Team Chair).

One of the first items we tackled was the need for an organized communications strategy to distribute and share materials and information to the Conference. The team developed the following strategy based on the timeliness of the information to be disseminated:

- For reporting on big topics and big events: The Friend mailed 6X yearly.
- Timely information: Coconut Wireless (inputs from team on local and national J & W)
- Immediate distribution:
  - Facebook—broader base
  - <u>Twitter</u>—breaking news and leads to other communities in the Conference and the UCC. Material is available to be tweeted to a broader audience.
  - o <u>YouTube</u>—to share activities, music, presentations, etc.
  - HCUCC and UCC J & W web sites

Our other focus item was getting more people, associations, and congregations involved in J & W activities. To do this the team adopted a change to our approach. We will now have a core team whose function is to look at the big picture in the Conference and nationally for justice issues, and J & W missionaries to the island Associations, AHEC, SCHCC and churches. Justice missionaries will be a point of contact for obtaining J & W materials, speakers and other information, in addition to the core team. They are the liaisons for providing speakers or the program for Association meetings. We hope that the missionaries can become an integral part of their Associations. Working at the association level they can develop contacts in churches that are doing Justice work or want to get involved with Justice issues. As the relationships grow J & W missionaries can help Associations share their Justice activities by highlighting the work of the churches via one of the methods above. J & W missionaries will assist the core team in providing relevant information from HCUCC and UCC justice activities. Our hope is that some of the missionaries may be young adults who could assist their Associations and churches with locating and distributing online material and information.

A prototype for developing a justice focus was completed on Kauai. An LED\* workshop was held for churches on the island. The workshop leader was trained in leading groups to find their justice passion. Out of the meeting came focus areas for congregations and for the island Associations. There is a J & W missionary working with them to continue the work that was started. As we progress we will follow the structure of this prototype. First, have a group participate in an LED workshop (4 hours). This is something that can be done as the program for Association meetings or after church. A J & W missionary will work with churches to follow up on the topics and activities selected. We hope to recruit some young adults to teach churches how to locate information or make web information available to the churches. It is our hope that the J & W missionaries can become part of the Association meetings and give feedback on programs, materials and justice issues that were chosen. They can also share the larger picture of Justice activities from the UCC and HCUCC.

The core J & W team will continue to work on conference-wide, association and national issues. One of their goals will be to keep a J & W electronic presence on Facebook via the HCUCC J & W page, with the HCUCC Justice Twitter feed, as well as in the <u>Coconut Wireless</u> and other publications of the Conference. The core team will be mentors for the J & W missionaries. The core team will provide timely new J & W information from the national J & W Team and the Conference J & W team. By working together with the J & W missionaries, local justice issues may be raised to a Conference level.

With this two-pronged approach we can address local justice and witness issues and continue to keep a focus on the larger issues that can have an impact on all.

#### Christian Investment Grant Awards:

Training will be held in September on Oahu and the award will provide support to help defer some training costs for UCC clergy and members taking the training.

- Rev. Dean Fujii, \$100.00 for continuing education for the 2016 Clergy Retreat.
- Rev. Iese Opetaia, \$322.00 for continuing education for the 2017 Clergy Retreat and \$500.00 for an online UCC Polity class.
- Rev. Wayne Higa, \$500.00 for continuing education for the 2017 Clergy Retreat.

#### Planned Giving:

• Friends of the Conference (FOC) giving for 2016 totaled \$19,480.00: The average donation was \$114, there was an increase in the number of \$1,000+ gifts and \$500-\$1,000 range. 100% of Conference Staff gave to FOC.

### OCWM (Our Church's Wider Mission) Initiative:

- Total 2016 OCWM contributions received was \$287,666.03, a slight decrease of \$3,023.60 over 2015. There is a sustained effort by Associate Conference Ministers to educate churches and clergy about OCWM and its impact in enabling conference programs that support churches, clergy and youth.
- A new Hawaii OCWM brochure was published and shared displaying in pictures and words how OCWM is used in Hawaii, nationally and in the world.
- At the February 25, 2017, Church Leaders Event, OCWM was prominently displayed in banners, a PowerPoint of participating churches and shared information on how churches' giving benefits churches and individuals locally.

In our Christian life we believe everything is created and belongs to God (Psalm 24:1); it is God who provides and owns. As Christian stewards we have responsibility to use and manage God's gifts. We are accountable for our decisions and actions as stewards. The Stewardship Missional Team's emphasis on support of Our Church's Wider Mission (Five for Five includes OCWM basic support and the 4 special offerings: Strengthen the Church, One Great Hour of Sharing, Neighbors in Need, and Christmas Fund) is the step for our churches' stewardship to keep their covenant with the United Church of Christ to serve God's people here in Hawaii and throughout the world.

2017 Aha Makua of the 195<sup>th</sup> Aha Pae'aina Kamehameha Schools – Maui

Hawaii Conference of the United Church of Christ Annual Meeting June 16-17, 2017

Aloha Kakou,

In October 2016, the State Council of Hawaiian Congregational Churches (SCHCC) held a two(2)-day Board of Director's Meeting in West Hawaii, hosted by the West Hawaii Council of Hawaiian Congregational Churches. We had the opportunity to visit and talk story with representatives of Helani, Lanakila, Kahikolu, Pukaana, Hauoli Kamanao, and Kauahaao, member Churches of the West Hawaii Council.

In particular, the history of Henry Opukahaia as shared by Gordon Leslie, at Kahikolu in Napoopoo, and Kahu Pono Debbie Wong Yuen, at the Henry Opukahaia Chapel in Punaluu, was very educational for us. Mahalo to Gordon and Debbie for the valuable information.

The Bicentennial Anniversary of the arrival of the first missionaries will be celebrated in 2020, and we are happy to share that Aunty Aletha Kaohi has been appointed, by the SCHCC Board, to represent the SCHCC on the planning committee. On another "planning" note, the SCHCC will take the lead with the planning of the 2018 Aha Iki for the 196<sup>th</sup> Aha Pae'aina.

Since the Aha Makua of the 194<sup>th</sup> Aha Pae'aina, we have come through a season of hate, anger, un-forgiveness and love which was triggered by complaints and concerns raised by a group who were dissatisfied with the Hawaii Conference United Church of Christ (HCUCC). To address the group's concern, a Consultant was hired to conduct interviews with individuals and focus groups, which resulted in an assessment summarized by that Consultant. The Assessment has been made available on-line by the HCUCC.

The Conference Council of the HCUCC, recently approved the appointment of the SCHCC as Custodians of the Katherine and Clay Wery Fund. The SCHCC has begun discussion on the purpose and use of the funds.

The Repair & Maintenance Fund, a line item in the Hawaii Conference Foundation budget, remains at \$40,000.00, after efforts by the SCHCC (as Custodians) to increase that allocation failed.

On a bittersweet note, Kahu Charles Buck has announced his resignation as Conference Minister. On a happier note, his resignation stems from a job promotion offered to his wife Susan, which she accepted. Our best wishes and blessings on a new chapter of their journey.

With the recent notice of Kahu Buck's resignation, an Intentional Interim Search Committee has been formed and Kahu Kealahou Alika will represent the SCHCC on that Committee.

As FY 2016–2017 comes to a close, the State Council of Hawaiian Congregational Churches continues advocating on behalf of our Hawaiian Churches of the Hawaii Conference.



The auditors issued an unmodified opinion on the financial statements of the Hawai'i Conference United Church of Christ and Hawai'i Conference Foundation.

## ANNUAL REPORT 195<sup>th</sup> 'Aha Pae'aina June 2017

#### Introduction

The Hawai'i Conference Foundation ("HCF") holds title to and manages the assets for the Hawai'i Conference. It also holds title to several church sites. The Members (owners) of the HCF are the 11 members of the Board of Trustees together with all the members of the Conference Council of the Hawai'i Conference United Church of Christ (several of whom are also members of the Board of Trustees).

As of June 30, 2016, the HCF managed financial assets totaling \$52,889,676. These assets consist of cash, receivables, non-real estate investments, some property, and equipment.

#### Asset Management

As of June 30, 2016, the investment portfolio totaled \$38,824,936, and was comprised of cash, money market funds, government and corporate bonds, structured notes, and common and preferred stocks. Nearly \$11.2 million of this investment portfolio represent funds belonging to and managed in custodial accounts for churches and associations and is not the property of the HCF.

#### Real Estate

The HCF holds title to 43 fee simple units at the Craigside Condominium, Tower III, as well as the leased fee interest in 19 units in Towers I and II. This property is what remains of the Mission Memorial assets. The leased fee interests are in negotiation with the lessees for a new lease rent.

#### **Partnerships**

The Palapala Ho'omau Preservation Society and Huialoha Preservation Ahahui partnerships are going well. The Palapala Ho'omau Preservation Society completed its restoration and held a rededication service. The Huialoha Preservation Ahahui has completed the church repairs which include a new roof and flooring. Both these partnerships are reaching out to the community for support, freeing the HCF to use its resources for other missions.

The Kahikuonalani UCC partnership with a preschool operator moved forward with a new sanctuary, meeting hall, and kitchen facilities. Construction is done. The facility is cleared for occupancy.

The Kauhikoa Road property in Haiku, Maui is in the hands of a daycare provider on the makai half and UCC Pohnpei Maui on the mauka half. The daycare provider completed its property improvements at an estimated cost of over \$75,000. UCC Pohnpei Maui is reorganizing itself after half the congregation left and found a new church.

The Coan Trust is seeking court guidance on declaring a beneficiary for the trust and we are seeking partners to use the millions of gallons of water flowing into Hilo Bay every day.

#### Audit

The HCF received an unmodified (the new term for what was a "clean" or "unqualified") audit opinion from KMH LLP for its financial statements for the fiscal year ending June 30, 2016.

## Hawai'i Conference Foundation's Endowment

A majority of the funds managed by the HCF are *endowed* funds. Endowments are *restricted* or *unrestricted*, determining how the income from the funds may be used. Restricted funds can only be used for the purposes stated in the fund directives.

The HCF Endowment Fund comes from gifts and bequests to the Hawai'i Conference. Such endowment gifts have been made to the Hawai'i Conference since 1883.

The Hawai'i Conference draws money from its unrestricted endowment to fund that portion of its budget that is unmet from the giving of local churches and other revenue sources.

Of the \$38,824,936 market value of the HCF's total investment portfolio as of June 30, 2016, only about 31%, or \$11.9 million, of this money is unrestricted and available to use for general Hawai'i Conference and HCF purposes. Another 28.5%, or \$11.2 million, belongs to local churches and associations in the Hawai'i Conference. The remainder of approximately 40.5% of the investment portfolio is restricted in its use.

#### The Richards Friend Peace Scholarship Endowment

The Richards Friend Peace Scholarship Fund, established in 1911 by Theodore and Mary Atherton Richards, has over \$1.8 million in its permanent corpus. The funds are managed by the HCF.

Scholarship applicants are drawn from Pacific nations coming to study in America and its possessions or from America and its possessions to the Pacific. Students from the following countries are eligible to apply for scholarships: American Samoa, China, Federated States of Micronesia, Fiji, Japan, Korea, Marshall Islands, Palau, Philippines, Taiwan, Western Samoa, and the U.S.

Awards are made on the basis of ability, need, and character. Persons with Christian connections and experience with the United Church of Christ or its affiliated churches have priority. Applications are available online at the Hawai'i Conference website (www.hcucc.org).

#### **Investment Management**

UBS Financial Services Inc. serves as a third-party investment management monitor, for a fee, assisting with the selection and supervision of the investment management firms that manage the HCF securities. UBS Financial Services Inc. monitors the performance of the investment managers and provides the Trustees of the HCF quarterly evaluation reviews of the performance of the managers in relation to published indexes of comparable investment portfolios.

The investment managers are given full discretion to make all investment decisions for the assets placed under their control while observing and operating within the constraints and philosophies outlined in the Statement of Investment Policy.

About 51% of the HCF's funds are invested with the United Church Funds, the national equivalent of the HCF.

- International Equity 10.3%
- Domestic Equity 51.6%
- Structured Notes 33.7%
- Domestic Fixed Income 4.4%

The structured notes seem to violate the HCF's Statement of Investment Policy but UBS Financial Services Inc. assures us it is a proper investment.

First Hawaiian Bank is the custodian of these funds and charges the HCF a custodial fee.

#### **Operating Revenues**

In fiscal year 2016, total revenue was \$1,246,873. This included market losses of \$313,084 on investments.

Operating expenses for the fiscal year ending June 30, 2016, were \$1,558,704. These expenses consist of salaries and benefits, travel for meetings, professional and consulting fees, materials and supplies, equipment leases, and support to the mission of the HCF and the Hawai'i Conference. Also included in the administrative budget of the HCF are the property expenses that support the Conference, the associations and their respective churches. The property related expenses include insurance, repairs and maintenance, and real property taxes that are not reimbursed.

#### Service to Local Churches and Associations

During the fiscal year ending June 30, 2016, \$314,576 was spent on financial support services for member churches and associations.

The HCF provides in-kind direct services to churches and associations of the Hawai'i Conference United Church of Christ. These include facilitating insurance coverage for church properties, advising on matters related to non-profit issues, providing investment assistance through custodial accounts along with administration of those accounts for local church and association endowment funds, correcting outstanding legal issues to bring a property into conformance with existing rules and regulations, providing help and guidance in acquiring or disposing of assets, and presenting education programs related to church operations and management.

The HCF manages the investment funds for over fifty churches and associations. An administrative charge (0.10% or 10 basis points) is assessed to these funds. This charge covers only a fraction of the total costs of the service and is about 10% of costs for comparable services charged by outside service providers, who charge from 1-2%. The HCF provides safekeeping for securities, collects all dividend and interest payments, keeps all the records, and makes and accounts for church withdrawals and deposits. The HCF also provides custodial account holders with quarterly statements.

### Management of 21 Craigside Apartments

The HCF owns 43 apartment units at 21 Craigside Place, of which 16% are leased to United Church of Christ related tenants at a discounted price depending on the tenant's ability to pay. These Craigside "Kokua" grants, the difference between the rent paid and the market rent, totaled about \$44,536 this year. The building is currently fully leased.

#### Administration and Management

The Charter of Incorporation reads that the direction and management of the affairs of the HCF and the control and distribution of its property are vested in the 11 members of the Board of Trustees.

There are four categories of Trustees:

- (a) Three are Conference Council members elected to the Board of Trustees for a two-year term by the Conference Council.
- (b) Two members are the Conference Minister and the Conference Council Chairperson who serve by virtue of the office they hold.
- (c) Four are nominated by the Board of Trustees and elected to up to two four-year terms by the Conference Council.
- (d) Two are nominated by the Conference Council and elected by the members of the Conference at the Conference's annual meeting for a four-year term.

The Chairperson and Vice Chairperson must come from categories C or D of Trustees.

### **United Church of Christ Transition House Annual Report 2016-2017**

The United Church of Christ Transition House (UCCTH) provides a safe haven, counseling and basic support for women and their children who are survivors of domestic violence. Over the years, most of these families served by UCCTH have successfully transitioned from the program to independent living.

The UCCTH reflects a multi-faceted ministry in its organizational framework. The major components are included in the following report that reflects an activity summary for the year.

### Organizational/Board Responsibilities

The Board is adjusting to the "retirement" of our previous co-chair Rev. Grant Lee who served on the Board for over 12 years. Recruitment of Board members with backgrounds in fundraising, accounting, grant writing and a clergy replacement continues to be a priority. A major accomplishment has been a five year lease agreement between the UCC Transition House and the Church of the Crossroads with an option of an additional five years. This formalized relationship made in May, 2016 enabled UCCTH to successfully apply for grants that support capital improvement. The Transition House Board now assumes responsibility for all upkeep and improvements to the property and communicates with progress reports to Church of the Crossroads. The newest Board member Valerie Wayne, also a member of Church of the Crossroads, is UCCTH Board co-chair and is the liaison contact with the church.

The UCCTH Board of Directors is a working board that manages the business of the organization which includes providing support to the staff, overseeing facility maintenance and fiscal management, fundraising and maintaining liaison with UCC Churches. The Board meets monthly and consists of eleven members of which eight are representatives of UCC churches. Staff includes the UCCTH Director, Ms. Geraldine Kundis and Resident Night Manager Ms. Diana Kimbro. During this year, Ms. Kundis was on leave for six weeks as she was the sole caregiver for her late father, but coverage was provided by Board members and Ms. Kimbro.

The UCCTH is a 501(c)(3) non-profit organization with membership in the UCC Council for Health and Human Service Ministries (CHHSM) which provides non-financial resources and support.

#### **Facilities and Program Services**

Facilities: We received grants from the Atherton Family Foundation (\$22,000) and the First Hawaiian Bank Foundation (\$10,000) which provided funds for much needed major renovations, including total roof replacement and electrical work. Thanks to Beverly Rexrode and Annette McClendon, these two major projects were coordinated and completed in 2016 by qualified contractors from Western Pacific. Another company Johnson Control donated their services and volunteered to work on multiple projects around the house including repairs and painting in addition to generous donations of supplies, books, toys and money. A major concern with rat infestation resulting from the adjacent property owned by Church of the Crossroads was immediately resolved with pest control measures.

<u>Program Services</u>: This year, the UCCTH served five women and eleven children. The women participate in counseling, practicing fiscal and financial responsibility (i.e. establishing a savings account for future living arrangement needs) and transitioning to long term housing arrangements. It is always a joy to hear from our residents who have affirmed the House as a place where they feel safe and where healing is facilitated. Many of the "graduates" from the House return to "give back" to the place they call home. They often return to assist in volunteering and sharing their stories with current residents.

Presentations to thank and update UCC churches and to share stories from the residents, were made by the Church Liaison members. This helps to increase the awareness and support of the UCCTH ministry.

### **Fiscal/Fundraising Concerns**

Our Fifth Annual Fundraiser, "Beside Still Waters" was held on November 10, 2016 at the Central Union Church. This was also a celebration of the 25th Anniversary for the Transition House! Our inaugural logo designed by Richard Young, UCC Judd St. was featured. Our theme song "Because of You" composed and arranged by Kenneth Makuakane was highlighted, which gleans stories of women and their children who shared their experiences of pain, fear and doubt which were transformed into new beginnings, hope and healing. An anonymous surprise donor has been matching a "15 Minute Challenge" up to \$1,000 for the past two years which has been tremendous in raising an additional three to four thousand dollars. This fundraiser helps a great deal in providing for ever increasing operational expenses.

We are especially thankful to God for skilled and gifted Board members who have volunteered hours of work submitting grant proposals to fund ongoing capital improvement projects to maintain and sustain the house. Churches, individuals and community organizations continue to be generous and supportive contributors. Donations including our grant funds, fundraising event and campaigns below yielded a total of \$105,515 in 2016; these provided much needed additional income for operational expenses and capital improvement during the past year.

Three important fundraising opportunities continue to be lifted up:

- 1. The *Give Aloha* Campaign sponsored by the Foodland Stores during the month of September, yielded a total of \$1,880
- 2. The Hawaii Pacific Area *Combined Federal Campaign* (CFC) contributions were renewed for 2016 with approximately \$325.
- 3. In our 2<sup>nd</sup> year as a member, the *Aloha United Way* has contributed donations of approximately \$1,700.
