
Welcome!

Hali`a Aloha Cherished Memories Honoring Kahu Charles Buck

Welina: Greetings – Aletha Kaohi

Pule Ho'maika'i: Prayer of Thanksgiving - Kahu Kealahou Alika.

Olelo iku lani: Boyd Matsuyama shared the history and purpose of our gathering. Our ancestors saw a need to unite the Hawaiian Churches and out of that concern, the State Council of Hawaiian Congregational Churches was established in 1948, 69 years ago, and still a viable organization. SCHCC has benefitted from Kahu Charles Buck's leadership and wisdom. As the host organization SCHCC is a member of the Hawai'i Conference Council of the United Church of Christ.

We gather to express our aloha and mahalo to our pastor, teacher and friend Kahu Buck. Inspired by Kahu Buck, Keoki Kiwaha, member of Puka`ana Congregational Church, composed a haku mele, "Ka Leo Ku`i Hekili", a gift of admiration and gratitude." **Haku Mele: Ka Leo Ku`i Hekil`i"** – Composed by Keoki Kiwaha. As Keoki Kiwaha read each line in Hawaiian, Sharon Matsuyama translated in English.

He Pilimai: Kahu Buck was invited to come forward. Aletha Kaohi placed "Piko" in his hands. SCHCC Executive Committee members stood with Kahu Buck. Frank Mulec invited representatives from the seven Island Councils and the two Partners to tie a ti-leaf cordage on to "God's Piko."

Mana'o: Aletha Kaohi – The "Piko" designed with braided green ti-leaves symbolizes connection and protection. When making this sacred "piko", GOD'S PIKO, pause to "mihi" (forgive) and "ma'ema'e" (cleanse) "huikala" (purge) until empty of opala (rubbish)

We believe that we have three "piko", which connects us to the past, present and future.

Past: Crown of the head connects us to ancestors.

Present: Umbilical cord connects us to 'ohana (family).

Future: Genitals connects us to descendants.

It is a pleasure, a privilege and an honor to pay tribute to Kahu Charles Buck. The lyrics of the Haku Mele are woven into God's Piko. For the past thirteen years Kahu Buck has served as Conference Minister, pastor, teacher and friend. As SCHCC's spiritual advisor, Kahu Buck will be missed and we express our aloha through this simple "Piko Ceremony." We are connected for each braided leaf represents a member of the State Council of Hawaiian Congregational Churches.

Makana: The Queen's Song Book.

Haku Mele:"Ka Leo Ku`i Hekili", framed.

Triple Piko – A kukui nut, wrapped with a netting and three (3) puka shells. .

The kukui nut (candle nut) - enlightenment and knowledge.

The mesh/eyes of the net – vision.

The knots of the mesh - connecting to the past, present & future.

The puka shells – the triple piko.

Pule Ho'oku'u: Closing prayer – Kahu Charles Buck.

SCHCC Committee for the Repair & Maintenance of Small Membership Hawaiian Churches

2018 ANNUAL REPORT

Four grants were approved for the fiscal year 2017-2018. The funds available for disbursement was \$40,000.00. Applications were received from the following churches.

- Kapa'a First Hawaiian Church, Kapa'a, Kaua'i
- Ka Hana O Ke Akua, Wai'anae, O'ahu
- Ola'a First Hawaiian Church, Kurtistown, Hawai'i
- Kalaiakamanu Hou Congregational Church, Kaunakakai, Moloka'i

KAPA'A FIRST to HAWAIIAN

Because there was not sufficient funds during the 2016-2017 fiscal year meet the needs of all applicants, the application from Kapa'a First Hawaiian Church for the repair of the roof of the sanctuary was carried over the 2017-2018 fiscal year. The recommendation to approve a grant of \$18,000.00 was made in light of the need for the repair work to be completed before the Makahiki seasonal rains.

The Board approved the recommendation on July 27, 2017.

KA HANA new

Ka Hana A Ke Akua submitted an application for the installation of a

new O KE AKUA

ADA access ramp to the church. The delivery and installation work is to be done by Hawai'i Modular Space.

The Committee's priorities include a serious consideration of repair and maintenance work for churches to be ADA-compliant and EPA-Compliant, it was the recommendation of the Committee that the Board of Directors approve the application for the installation of a new 35' ADA Switchback Ramp for \$11,115.00. The SCHCC Board of Directors approved the recommendation at its January 27, 2018 meeting.

OLA'A FIRST HAWAIIAN

Ola'a First Hawaiian Church returned the unspent portion for a grant that they received in 2017.

The project for 2017-2018 was for termite treatment of the sanctuary and restroom. The cost was \$2,450.00. The church contributed 50% of the cost for the work to be done.

As a member of the Committee and as a member of Ola'a First Hawaiian Church, Kalei Tong abstained from voting.

The Committee recommended that the SCHCC Board of Directors approve a grant of \$1,225.00 for the termite treatment of Ola'a First Hawaiian Church. The recommendation was approved by the Board on January 27, 2018.

HOU

KALAIAKAMANU The overall cost for the project at Kalaiakamanu Hou Congregational Church was \$35,464.31. The project was a repair and renovation of the social hall of the church. In 2017 structural engineers determined that the church's foundation had deteriorated to the point that the church structure was no longer sound and safe.

> A decision was made to renovate the social hall and to move the worship services to that location. C&P Creations, a licensed contractor, was asked to bid on three separate projects including 1) Church Hall windows;

2) Church Hall flooring; 3) Church Hall painting.

The church's contribution to the overall cost of the project was \$12,000.00. The church received a grant of \$8,000.00 in 2017. The two grants will make it possible for the church to complete work that will allow the congregation to worship in the social hall.

The Committee recommended that the SCHCC Board of Directors approve a grant of \$9,670.00 for the repair of their social hall. The recommendation was approved by the Board on January 27, 2018.

DECISION MADE

Committee members agreed by consensus that all future grantees will be asked to provide a financial statement of all income and expenses upon completion of the project.

The "William Kahuakai Keliihoomalu Scholarship Fund" was established as a memorial Scholarship in 1979, following the passing of Licentiate Kahu, William K. Keliihoomalu. The fund was started with a monetary gift of \$25.00 by Mrs. Ada Larrison, a friend of the family, and continued growing with support from members of the Keliihoomalu 'Ohana, Kalapana Maunakea Congregational Church, and many friends. She requested that this gift be placed in a Custodial Account with the Hawaii Conference Foundation, for the purpose of providing financial aid for seminary, postgraduate and continuing education expenses. When the fund grew to the amount of \$500.00, the State Council of Hawaiian Congregational Churches (SCHCC) was appointed Custodian of this Scholarship fund. The State Council of Hawaiian Congregational Churches turned the funds over to the Hawaii Conference Foundation to be invested, setting a goal of reaching the amount of \$5,000.00, with the intention of using the earned interest income towards the granting of scholarships, for the purpose stated. Moloka'i Topside Report for 2017

The year 2017 has certainly gone by so quickly with many good things that transpired at our Topside churches.

First, the congregations from Ho'olehua, Kalaiakamanu Hou, Kalua'aha and Waialua churches are enjoying the ministry of Kahu Charles Poole as interim kahu. His wife, Elaine has been a great partner in assisting Kahu in many ways with his ministry.

Next, Topside officers' term of office ended in July for Chair, Norman Levi, Treasurer, Uluwehi Sai and Secretary, Tina He-Lindsey. New officers were inducted during Combined Services at Kalua'aha in September. The new officers are Cochairpersons, Pualani Akaka and Earline Iaea, Treasurer, Uluwehi Sai, and Secretary, Tina He-Lindsey.

Under the leadership of Kahu Kordell Kekoa, the Kamehameha Schools Deputation team's visit in January is always a welcomed event at our churches and the congregations looked forward to their visitation. Plans to visit Kalaupapa did not evolve so the group of students and chaperones did a workday at Kalua'aha by weeding inside the church sanctuary and cleaning the cemetery. Their assistance was very much appreciated.

Quarterly combined services held at each church throughout the year started off with Ho'olehua in March, followed by Waialua combined with Ho'ike in June, next, Kalua'aha in September and last of all, Kalaiakamanu Hou in December. A sermon for each combined service by Kahu Poole was very inspirational. All in attendance also enjoyed the onolicious pa'ina after service.

We are very excited that we have a member from Ho'olehua Church who is interested in becoming a minister. The church members are sponsoring Pualani Akaka who is a Member in Discernment, for a license in ministry from the Tri-Isle Association. She is under the mentorship of Kahu Linda Petrucelli. Kahu Poole has also been a great mentor to her. She has been attending various workshops sponsored by the UCC and learning more about the various aspects of our UCC ministry.

Special holidays throughout the year were celebrated with the different congregations and people from the various communities on island. Easter Sunrise service for the early risers at Waialua Church with breakfast after service; Thanksgiving lunch for Kupuna at Home Pumehana and for those who would otherwise be alone with no family to celebrate with on this occasion. This was our first endeavor of preparing and serving a complete Thanksgiving meal, but with Ke Akua's help, donors from Friendly Market and church members we were able to do this service. We were thankful to our chairperson, Uluwehi Sai for chairing this event. December is always a busy month, but Ho'olehua and Waialua churches both held Christmas Eve services which were well attended. Another festive activity enjoyed by the community was the appearance of the Community Choir that included some of our church members who performed at different denominational churches on island.

A focus this past year for Topside Council was Community involvement. Different types of events evolved such as the Thanksgiving Luncheon and Community Choir mentioned in the previous paragraph, free haircuts and mini manicures by Paul Mitchell Salon hairstylists and trainees, family movie nights during the summer months where families could bring their chairs, blankets, food and enjoy the movie outdoors and fellowship with other people on the front lawn of Kalaiakamanu Hou Church and quarterly Farmers Market held at the Waialua Church pavilion.

Moloka'i has seen more of its share of suicides on island and community members have been meeting to discuss ways to deal with this issue. The goal was to provide hope against the effects of depression, drugs, alcohol, and abuse. Kahu Poole has been attending meetings with other ministers and community leaders and reports back to Topside Council. Various activities included sign waving, whole island involvement with an Island Walk starting from East and West Moloka'i and ending with a rally at Kaunakakai Public Library. Meetings will continue in 2018.

Last of all, Waialua church members were so grateful for grant monies received from SCHCC that enabled them to renovate the old church building into a Sunday School Building. This renovated building was named Arthur and Winnie Naehu Sunday School Building and dedicated in June 2017. Keiki and makua are making good use of this beautiful renovated space for Sunday School classes. Another happy recipient of grant monies is Kalaiakamanu Hou Church who will use the funds for renovations to the Social Hall in anticipation that the church sanctuary might not be safe for occupation within 1-2 years. Mahalo to the SCHCC for making grant monies available to the churches for repair and maintenance.

The Topside Council of Moloka'i will be doing their best to continue representing their congregants and work together to do God's ministry on island.

Ka`ahumanu Congregational Church

Wayne Higa is Kahu Pono. Work continues in the renovation of Ka`ahumanu Church. On January 28, 2018, King Lunalilo was commemorated on Ali`i Sunday. On March 18, 2018 Ahahui `O Ka'ahumanu, the Royal Order of Kamehameha, and Hale o Na Ali`i celebrated the **250**th **birthday of Ka`ahumanu.** Ho`ike was held on April 7, 2018. Annual Pulelu Fundraiser will be on April 21, 2018.

Kahakuloa Hawaiian Congregational Church

In June 2017, the roof of the church collapsed leaving the foundation and 1 wall intact. With the help of the community, church leaders, and donated manpower from construction companies, the debris was removed and work began on the foundation and walls. In March the roof was in place, With the leadership of Kendall (Chico) Ka`onohi, the congregation hopes to reopen the church on June 11, 2018, 1 year after the collapse.

Sadly, **Uncle Richard Ho`opi`i, passed away in early March**. There was a service for Uncle Richard in Kahakuloa on March 26. Ho`olaule`a is planned for May 5, 2018.

Keawala'i Congregational Church

Reverend Kealahou Alika is the pastor. Church services are at 8:30 and 10:00 AM on Sundays. Their annual luau in March, as always, was enjoyed by kama`aina and malihini.

Keolahou Congregational Hawaiian Church

Keolahou Congregational Hawaiian Church continues to hold Sunday worship services with supply preachers from the community. Our weekly Food Pantry mission continues with excellent support from members, clients, other community individuals and church partners. We serve an average of 130 households. We also provide a dinner meal monthly for those at the Wailuku Homeless Shelter, Ka Hale A Ke Ola.

Our support of Hawaiian culture and values is demonstrated by our sponsoring of weekly Hula lessons under the leadership of a local Halau Na Pua o Kaiwa and Kumu Noelani Forsberg and a weekly ukulele/Hawaiian songfest under the direction of "808ukejams" Kumu, Kealoha Delos Santos. We have experience a 15% increase in

membership since last year and our budget support remains strong and which will allow us to proceed with hiring half-time pastoral leadership in 2008.

Lahuiokalani Ka'anapali Congregational Church

Originally known as Ka`anapali Congregational Church, Lahuiokalani Ka`anapali Congregational Church was established in 1840. The foundation for the church has always been **lay leadership**, and that tradition continues today. Join us for Sunday services at 10 AM. The highlight for this year: we are ready to rebuild the Hale `Ai.

Olowalu Lanakila Hawaiian Church

It has been a quiet time for our church and congregation since the beginning of the year. Attendance has been steady. Kenneth Makuakāne paid a visit to our church last month and shared a typically wonderful message with our congregation.

My Goals As Luna Ho'omalu of AHEC

- Meet and create relationships with as many AHEC and Kalawina individuals and churches
 possible. (Progress? Although successful with the mainstream AHEC churches, I am still
 working on other Kalawina. I will continue to seek opportunities to continue and to expand on
 this Goal.)
- Continue to be open to learning opportunities and responsibilities of the Luna Ho'omalu and advocating for consistent and progressive growth of the Body of Christ within our Association and all denominational and ecumenical partners in Christ.
- Advocate for continuing educational oppportunities and workshops to keep all Kalawina informed and focused on the Mission and Goals of the Association of Hawaiian Evangelical Churches.
- Ensure the Association is fiscally responsible and sound Stewards of financial resources provided by Ke Akua.
- Advocate for the creation of a UCC Council for Native Hawaiian Ministry to continue building relations between the UCC and Native Hawaiians.
- To support efforts of our AHEC Committee on Ministry to create local educational opportunities and or make available affordable, accessible and mutiple educational pathways to encourage and prepare laity for ordained Ministry.
- To work closely with Partnership Ministries, providing mutual support and common goals to lift up the conditions of Hawaiian and all of God's people.

What Was Actually Accomplished?

- The work of meeting and creating relationship with AHEC Kalawina and other Hawaiian Churches and individuals has been somewhat successful during 'Aha and or actual island visitations. However, this work never ends and continues.
- I've learned so much and have a tremendous appreciation for all the Luna Ho'omalu that preceded me. One can never be prepared for the day to day, month to month and year to year tasks that come up while being the Luna Ho'omalu. However, I continue to do my best to meet and or exceed expectation of me as the Luna Ho'omalu of AHEC.
- We continue to search through old records and minutes, historical documentations and every resource available to understand what our Kūpuna envisioned during the creation of the Association of Hawaiian Evangelical Churches and began archiving and providing this information in 'Aha and 'Aha Nā Kahu workshops and other training opportunities as much as possible. These documents have also been valuable to our current work on our bylaws, introduction of new policies and visioning discussions over the past two years.
- In 2016, the Association approved the formation of an Investments Ad Hoc Committee to explore and or develop and create an Endowment Policy Statement that gives clear directions on how this Association manages and distributes its endowments. After going through several revisions this

policy was finally adopted at the February 10, 2018 Fall 'Aha Hālāwai at Ola'a Church. Also, our current Pu'ukū, Kerisa Carmello shared excellent and important training with our Board on how to read and review financial reports of the Association, something I hope will be continued in the future.

- It was my hope to attend the last General Synod to begin discussion with delegates UCC Staff members responsible for the development and creation of the UCC Council for American Indians for guidance in the creation of a UCC Council for Native Hawaiians. Much was accomplished since the UCC's "Apology to the Kānaka Maoli" address made by General Minister, the Reverend Dr. Paul Sherry, on January 17, 1993 to the Indigenous Hawaiian People on the grounds of 'Iolani Palace. The work is not over and fostering and building this work for the benefit of our Hawaiian people and churches with the United Church of Christ should continue as they have for our Native American Sisters and Brothers.
- The AHEC Committee on Ministry has worked hard these past few years with changing times and leadership. The COM has progressed into a great team addressing reforms in providing quality educational opportunities through mentorship, workshops, and curriculum development to inspire laity to ordination, including through the opportunities provided through multiple pathways for Ministerial Excellence, Support and Authorization. Currently, the Association will have ordained two Kahu (Kahu Mike Warren and Kahu Ken Makuakāne) and have six Members in Discernment.
- Fostering good relationships with our Partnership Ministries has been God driven. As Luna Ho'omalu, I've advocated for stronger relations with all Partnership Ministries, ensuring then and for the future, growth and sustainability together as One Body of Christ. It is important to remember what the Apostle Paul wrote in 1 Corinthians 1:9, "You were called into the fellowship of His Son, Jesus Christ our Lord." This means sharing vertically and horizontally in the union each of us has in Christ and "sharing" together with other believers the common union we have with Christ and each other. That being the sharing together in the Father and the Son as in 1 John 1:3, "That which we have seen and heard we proclaim also to you, so that you too may have fellowship with us. . ."

In Conclusion

We must never forget the founding principles of the Association of Hawaiian Evangelical Churches. In his report on the on the creation and development of AHEC, Kahu Merseberg wrote:

"... the Association of Hawaiian Evangelical Churches is the fulfilment of a dream which evolved through a growing process which began with the HCUCC Hawaiian Ministry Department and which included our Hawaiian Churches and Ministers and all HCUCC Hawaiian Groups in each part of the journey.

AHEC came about because our people wanted it to happen. The entire ohana or family of Hawaiian organizations in the HCUCC participated in all stages of AHEC's development; namely, the proposal writing, the interim governing board work, the Mission Statement development, the By-laws development and approval. Our people worked hard to make it happen.

AHEC is an expression of commitment on the part of our people to accept the responsibilities of a fully participating self-determining Association in the HCUCC. It's a means by which to empower ourselves to be solution makers for Hawaiian concerns inside and outside the Church. It's an instrument or conduit through which resources can flow to and from our churches. It's an agent to help encourage and strengthen our churches and our leadership, laity and clergy, to be faithful in God's mission. It's an official participant in the HCUCC BOD decision making."

Our work continues with many hills and valleys behind us, before us and yet to come. However, by the Grace of God, who is still speaking in our hearts we continue to make strides to ensure God's presence through Jesus Christ is present within our Hawaiian People and Churches.



- 5) This is an election year. All positions are open. Anyone considering being nominated for any position is encouraged to read "Celebrating Advocacy: Past, Present & Future", SCHCC's 60th Anniversary commemorative publication, to learn the history of the State Council of Hawaiian Congregational Churches.
- 6) The Repair & Maintenance Fund, a line item in the Hawaii Conference Foundation budget, remained at \$40,000.00 for FY 2017-2018 . Four (4) churches received funding, totaling \$40,000.00.

The 2018 Aha Iki is being planned by four (4) Partnership Ministries; the Association of Hawaiian Evangelical Churches (AHEC), State Sunday School Association (SSSA), Christian Endeavor – Hawaii (CE-H), and the SCHCC. Sharon Matsuyama represents the SCHCC, as Chairperson, on the 2018 Aha Iki planning committee. Other committee members include representatives from AHEC, SSSA and CE-H.

Special mahalo to Kahikuonalani Church, in Pearl City, for graciously hosting our quarterly Board meetings for the past two (2) years. The SCHCC has, indeed, been blessed by your generosity. Mahalo also to the Maui Council, for hosting our two (2) days Board meeting on April 27 - 28, 2018.

STATE COUNCIL OF HAWAIIAN CONGREGATIONAL CHURCHES NEW MEMBERSHIP PROCEDURES

New churches will be formed from time to time, desiring to be *considered for and accepted as* a member of the State Council of Hawaiian Congregational Churches.

The responsibility of recognizing new churches, into the State Council of Hawaiian Congregational Churches, is that of the Island Council.

Pre-requisite for Membership:

- 1) The New Church must be a member of an Association of the Hawaii Conference of the United Church of Christ (i.e. Kauai, Oahu, Tri-Isle (Maui, Moloka'i, Lana'i), Hawai'i or AHEC) who/which embraces Hawaiian cultural practices, including its language, its values and its traditions.
- 2) The New Church shall present a letter seeking membership and its church bylaws to the Island Council within whose bounds it is located.
- An Island Council, having received such a letter and bylaws, from the New Church, shall inquire as to its understanding of the United Church of Christ Polity.
 Membership requires commitment to attend and be an active participant at all Island Council Meetings and events, as well as be up-to-date with the payment of membership dues as required.
- 4) Upon reviewing the required documents and insuring that the New Church candidate understands and is in agreement with the United Church of Christ Polity, the Island Council shall present its recommendation to the State Council of Hawaiian Congregational Churches Board of Directors.
- 5) The State Council of Hawaiian Congregational Churches having received the recommendation of the Island Council shall, at its discretion, vote on membership.
- 6) Upon acceptance, the State Council of Hawaiian Congregational Churches shall conduct a Service of Covenant at its Annual Meeting (the Aha Iki) during the Aha Pae'aina.

Note: If a New Church candidate is not a member of an Association of the Hawaii Conference of the United Church of Christ (i.e. Kauai, Oahu, Tri-Isle (Maui, Moloka'i, Lana'i), Hawai'i or AHEC) but embraces Hawaiian cultural practices, including its language, its values and its traditions, the Island Council may consider Associate Membership status (as outlined in 2, 3, 4 and 5).

THE CONSTITUTION

of the

STATE COUNCIL OF HAWAIIAN CONGREGATIONAL CHURCHES

(Affiliate Organization of the Hawai'i Conference of the United Church of Christ)

PREAMBLE

The State Council of Hawaiian Congregational Churches celebrates and nourishes its biblical roots in the Christian faith, while sustaining the richness of Hawaiian traditions and cultural values. The State Council of Hawaiian Congregational Churches draws together Churches which strive to create opportunities for spiritual growth, leadership and commitment in order to attain a common vision. This vision embraces the nurturing of all people to become instruments for building a better world and community.

ARTICLE I: NAME

This Council shall be known as the State Council of Hawaiian Congregational Churches (hereinafter referred to as the SCHCC), an affiliate organization of the Hawai'i Conference of the United Church of Christ (hereinafter referred to as the HCUCC).

ARTICLE II: PURPOSE

To advocate at all levels of the Hawai'i Conference of the United Church of Christ in the best interest of the Hawaiian churches.

ARTICLE III: POLITY

The SCHCC is a voting member of the HCUCC, as described in the Charter and Bylaws of that organization.

The governance of the SCHCC is vested in its member churches, who shall exercise the right of control in all its affairs subject to the laws of the State of Hawai'i.

ARTICLE IV: MEMBERSHIP

Section 1. Members

- 1. Member churches of the SCHCC; Island Councils, within the HCUCC.
- 2. Member churches embracing Hawaiian cultural practices, including its language, its values and its traditions.
- 3. Member churches shall have a voice in the affairs of the SCHCC and the right to vote as provided in its Bylaws.

Section 2. Delegates

- 1. An active member church shall be entitled to one lay delegate. Churches having more than 200 members shall be entitled to elect one additional lay delegate for each additional 100 members, up to a total of five delegates.
- 2. Each active member church shall also be entitled to elect one youth / young adult delegate, twenty five years of age or younger.
- 3. One authorized minister (ordained, licensed or commissioned) from each active member church.

Section 3. Annual Dues

An active member church is one which is current in payment of their assessed dues. Each member church shall be assessed annual dues. Dues shall be paid and recorded by the Treasurer by January 31.

ARTICLE V: BOARD OF DIRECTORS

The management of the business and affairs of the SCHCC shall be the responsibility of the Board of Directors, which shall consist of the Officers of the SCHCC, one (1) representative from each of the Island Councils and one (1) representative from each Partnership Ministry; such number of directors as outlined in the Bylaws of the SCHCC but under no circumstances less than five (5). Subject to such limit, the member churches may increase or decrease the number of Directors at an Annual Meeting. In the event the Board membership falls below the minimum of five (5), the SCHCC Board of Directors shall make interim appointments for the unexpired term(s). The Directors shall be qualified, nominated, elected, and appointed as provided in the Bylaws. Each Director of the SCHCC shall serve until his or her successor is duly elected.

Section 1. Officers

The Officers of the SCHCC shall be a President, a Vice President, a Secretary, a Treasurer and an Advisor, all of whom shall be members in good standing in an active member church of the SCHCC and with such qualifications, duties and powers as may be provided for in its Bylaws. Except for the Advisor, Officers shall be elected at the Annual Meeting during the 'Aha Iki, or as otherwise provided in Article V above, and preferably with no more than two of the four officers from the same island. The Advisor shall be appointed by the President.

Section 2. Island Councils

There shall be one representative from each of the following Island Councils: Kaua'i, O'ahu, Moloka'i, East Hawai'i, West Hawai'i, Maui, and East Maui Hawaiian Ministry.

Section 3. Partnership

One representative from the Association of Hawaiian Evangelical Churches shall have the privilege of voice and vote.

Any other partnership shall have the privilege of voice only without vote.

ARTICLE VI: AMENDMENTS

This Constitution may be amended by two-thirds (2/3) vote of the delegates of member churches present at the Annual Meeting, provided notices of the proposed amendment(s) shall have been given to each member church at least 30 days prior to the Annual Meeting where voting will take place.

BYLAWS

of the

STATE COUNCIL OF HAWAIIAN CONGREGATIONAL CHURCHES

(Affiliate Organization of the Hawai'i Conference of the United Church of Christ)

ARTICLE I: MEMBERSHIP

Section 1. Members

- 1. Member churches of the State Council of Hawaiian Congregational Churches (hereinafter referred to as the SCHCC), Island Councils, within the Hawai'i Conference of the United Church of Christ (hereinafter referred to as the HCUCC).
- 2. Member churches embracing Hawaiian cultural practices, including its language, its values and its traditions.
- 3. Member churches shall have a voice in the affairs of the SCHCC and the right to vote as provided in Article I; Section 5. Voting Privileges of these Bylaws.

Section 2. Partnerships

- 1. One representative from the Association of Hawaiian Evangelical Churches shall have the privilege of voice and vote.
- 2. One representative from Pūʻā Foundation shall have the privilege of voice only without vote.

Section 3. Delegates

- 1. An active member church shall be entitled to one lay delegate. Churches having more than 200 members shall be entitled to elect one additional lay delegate for each additional 100 members, up to a total of five delegates.
- 2. Each active member church shall also be entitled to elect one youth / young adult delegate, twenty five years of age or younger.
- 3. One authorized minister (ordained, licensed or commissioned) from each active member church.

Section 4. Annual Dues

An active member church is one which is current in payment of their assessed dues. Each member church shall be assessed annual dues as recommended by the Board of Directors and approved at the Annual Meeting. Dues shall be paid and recorded by the Treasurer by January 31. In addition, each member church is required to be in good standing with their respective Island Councils.

Section 5. Voting Privileges

Each member church, lay delegate, youth/young adult delegate and minister as outlined in Article 1, Sections 1 & 2 of these Bylaws shall have voice only in the affairs at the Quarterly Board of Directors (BOD) meeting, and voice with vote at the Annual Meeting.

- 1. An active member church shall be entitled to one voting delegate. Churches having more than 200 members shall be entitled to one additional voting delegate for each additional 100 members, up to a total of five voting delegates.
- 2. Each active member church shall be entitled to a youth/young adult voting delegate.
- 3. One authorized minister from each active member church shall be entitled to a vote.
- 4. SCHCC Officers (Vice President, Secretary, Treasurer and Advisor) and BOD members shall have voting privileges at the quarterly Board of Directors meetings, Special meetings and Annual Meeting.
- 5. SCHCC President shall have voting privileges at the quarterly Board of Directors meetings, Special meetings and Annual Meeting, only in the event of a tie.

ARTICLE II: BOARD OF DIRECTORS

Section 1. Composition of the Board of Directors -

There shall be a Board of Directors consisting of the following:

- 1. The Officers of SCHCC (President, Vice President, Secretary, Treasurer and Advisor);
- 2. One (1) representative from each of the Island Councils (Kaua'i, O'ahu, Moloka'i, East Hawai'i, West Hawai'i, Maui, and East Maui Hawaiian Ministry);
- 3. One (1) representative from the Partnership Ministries (AHEC and Pūʿā Foundation).

Section 2. The purpose of the Board of Directors is to advocate, in the best interest of the Hawaiian churches, at all levels of the HCUCC.

Section 3. Tenure - Each SCHCC Officer shall serve for a term of two (2) years. Each Island Council representative and Partnership Ministry representative shall serve their terms as allowed by their respective bylaws.

ARTICLE III: OFFICERS

The Officers shall be members in good standing within an active member church of the SCHCC. There shall be a President, a Vice President, a Secretary, a Treasurer and an Advisor. The duties of the Officers shall be as follows:

Section 1. President:

- 1. Shall preside at all meetings of the SCHCC Board of Directors and the Executive Committee.
- 2. Shall be responsible for the administration of business affairs.
- 3. Shall prepare an Annual Report
- 4. May create and appoint Task Forces and Special Committees as needed, with the Board of Directors approval.
- 5. Shall be an ex-officio member of all Standing Committees, except the Nominations Committee, with voice only and no vote.
- 6. Shall represent the SCHCC on the HCUCC Council.

Section 2. Vice President:

- 1. Shall be the presiding officer in the absence of the President.
- 2. Shall assume the presidency in the event the President resigns or is not able to serve.
- 3. Shall chair the Committee for Repair and Maintenance of Small Membership Hawaiian Churches.
- 4. Shall prepare an Annual Report of the Committee for Repair and Maintenance of Small Membership Hawaiian Churches.

Section 3. Secretary:

- 1. Shall record accurate minutes of all meetings of the Board of Directors and the Executive Committee, including Special meetings pertaining to the business of SCHCC, as well as the Annual meeting.
- 2. Shall be responsible for compiling and preparing reports submitted by all Officers, the Advisor, Island Council Presidents, Committee Chairs and Partnership Ministries for the Annual Meeting handbook.
- 3. Shall provide a sign-in sheet for all meetings of the Board of Directors and the Executive Committee as well as for all delegates attending the Annual Meeting.
- 4. Shall include a copy of the previous year's Annual Meeting minutes in the current year Annual Meeting handbook.

- 5. Shall send Board of Directors and Special Meeting minutes to the members of the Board of Directors, 2 weeks prior to each scheduled Board meeting, with the agenda for the scheduled meeting.
- 6. Shall send Executive Committee meeting minutes to the Executive Committee, 2 weeks after the meeting.
- 7. Shall record any corrections and additions to all meeting minutes, after approval by the Board.
- 8. Shall issue notices of meetings one (1) month prior to each meeting by written notice, via email. (If no email access, then by U.S. Mail)

Section 4. Treasurer:

- 1. Shall receive and deposit all funds in an accredited financial institution approved by the Board of Directors of this Council.
- 2. Shall keep an accurate accounting of all funds received and disbursed and shall give a detailed report of all accounts at each Board of Directors meeting.
- 3. Shall prepare a financial report for the Annual Meeting.
- 4. Shall keep an accurate record of all member churches current with payment of their dues and notify the Secretary of those member churches in arrears by March 01 of each year prior to the Annual Meeting.
- 5. Shall make all payments by check. There shall be two signatures on the checks, those of the Treasurer and the President or Secretary.

Section 5. Advisor:

- 1. Shall have thorough understanding and experience of the SCHCC.
- 2. Shall advise the Board of Directors in matters of function, policy, church polity, past practices and historical background.
- 3. Shall prepare a report for each board meeting and the Annual Meeting.
- 4. Shall be appointed by the President and shall serve a term coincident with the President's

ARTICLE IV: TERM OF OFFICE

The officers of the SCHCC shall be elected for a term of two (2) years. They may not serve in the same office for more than two (2) consecutive terms.

The President shall have the authority, with approval by the Board of Directors, to fill any vacancy in the officer positions for an interim period until the next scheduled election.

ARTICLE V: REMOVAL OF OFFICER

Any officer may be removed by a majority vote of the membership whenever the best interest of the Hawaiian Churches and this Council is not served. - 7 -

ARTICLE VI: EXECUTIVE COMMITTEE

Section 1.

The Executive Committee shall be comprised of the Officers of the SCHCC. The Executive Committee is charged with the following responsibilities:

- 1. Prepare the agenda for all meetings
- 2. Establish the date and time of all meetings
- 3. Be an advocate for all member churches
- 4. Prepare the Annual Budget

ARTICLE VII: MEETINGS

All meetings shall be opened and closed with pule 'ohana.

Section 1. Annual Meeting

The Annual Meeting will be held during the 'Aha Iki at the 'Aha Pae'aina in June. During the Annual Meeting of the SCHCC, time shall be provided for business, spiritual and cultural awareness concerns.

The majority vote shall be the preferred method for deciding matters that are before the member churches at the Annual Meeting.

Section 2. Board of Directors Meetings Schedule

The SCHCC Board of Directors shall meet in July, October, January and April. All Board of Directors meetings are open to member churches, with the privilege of voice only, without vote.

Section 3. Special Meetings

Special meetings may be called by the Board of Directors, by written notice sent out electronically or by U.S. Mail fourteen (14) days in advance to active member churches, stating time, place and purpose of the special meeting.

ARTICLE VIII: STANDING COMMITTEES

Section 1. Standing Committees

The Standing Committees shall be: (1) Repair and Maintenance of Small Membership Hawaiian Churches. (2) Endowment / Scholarship.

The Committee chairpersons shall be members of the Board of Directors and will be appointed by the Board of Directors. The Chairperson of the Committee for Repair and Maintenance of Small Membership Hawaiian Churches, shall be the Vice President. The Chairperson of the Endowment / Scholarship Standing Committee will maintain the autonomy of the independently funded programs reporting through the SCHCC. (Endowment / Scholarship Standing Committees may include Kahu Richard Wong Endowment Fund, William Keliihoomalu Scholarship and others).

Section 2. Task Forces and Special Committees:

The President may establish Task Forces and Special Committees to address special issues and needs with majority approval votes from the Board of Directors.

ARTICLE IX: INDEMNIFICATION AND INSURANCE

Section 1.

The SCHCC shall indemnify each person who was or is a party or is threatened to be made a party to any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative, or investigative (other than an action by or in the right of the SCHCC) if that person is or was a director, officer or agent (hereinafter to include volunteers) of the SCHCC, against expenses (including attorneys' fees), judgments, fines, settlements, and other amounts actually and reasonably incurred in connection with the proceeding if the person acted in good faith and in a matter the person reasonably believed to be in or not opposed to the best interests of the SCHCC, and, with respect to any criminal proceedings, had no reasonable cause to believe the conduct of the person was unlawful. The termination of any proceedings by judgment, order, settlement, conviction or upon plea of nolo contendere or its equivalent, shall not, of itself, create a presumption that the person did not act in good faith and in a manner which the person reasonably believed to be in or not opposed to the best interests of the SCHCC and, with respect to any criminal action or proceeding, had reasonable cause to believe that other person's conduct was unlawful.

Section 2.

The SCHCC shall indemnify each person who was or is party or is to be made a party to any threatened, pending or completed action or suit in the right of the SCHCC to procure a judgment in its favor because that person is or was a director, officer, or agent of the SCHCC against expenses (including attorney's fees) actually and reasonably incurred by the person in connection with the defense of settlement of the action if the person acted in good faith and in a matter the person reasonably believed to be in or not opposed to the best interest of the SCHCC, except that no indemnification shall be made in respect of any claim, issue, or matter as to which the person shall have been adjudged to be liable for negligence or misconduct in the performance of the person's duty to the SCHCC unless and only to the extent that the court in which the action or suit was brought shall determine upon application that, despite the adjudication of liability but in view of all the circumstances of the case, the person is fairly and reasonably entitled to indemnity for such expenses as the court deems proper.

Section 3.

To the extent that a director, officer, or agent of the SCHCC has been successful on the merits or otherwise in defending any proceeding referred to in Sections 1 or 2 of this Article, or in defense of any claim, issue or matter therein, such person shall be indemnified by the SCHCC against expenses (including attorney's fees) actually and reasonably incurred by such person in connection therewith.

Section 4.

Any indemnification under Sections 1 and 2 of this Article (unless ordered by a Court) shall be made by the SCHCC only if authorized in the specific case upon determination that indemnification of the director, officer or agent is proper in the circumstances because the director, officer, or agent has met the applicable standard of conduct set forth in Sections 1 or 2.. The determination shall be made (a) by the Board of Directors by a majority vote of quorum consisting of directors who were not parties to the proceeding, or (b) if a quorum is not obtainable, or even, if obtainable if a quorum of disinterested directors so directs, by the independent legal counsel in a written opinion to the SCHCC or (c) by the court in which the proceeding is or was pending upon application made by the SCHCC or the director, officer, or agent or the attorney or other person rendering services in connection with the defense, whether or not the application by the director, officer, agent, attorney or other person opposed by the SCHCC.

Section 5.

Expenses incurred in defending any proceeding may be paid by the SCHCC in advance of the final disposition of the proceeding as authorized by the Board of Directors in a particular case upon receipt of an undertaking by or on behalf of the director, officer, or agent to repay such amount unless it shall ultimately be determined that the director, officer or agent entitled to be indemnified by the SCHCC as authorized in this article.

Section 6.

The indemnification provided by this Article shall not be deemed exclusive of any other rights to which those indemnified may be entitled and shall continue as to a person who has ceased to be a director, officer, or agent and shall insure to the benefit of the heirs and personal representatives of such a person.

Section 7.

The SCHCC shall have the power to purchase and maintain insurance on behalf of any director, officer, or agent of the SCHCC against any liability asserted against or incurred by the director, officer, or agent in any such capacity or arising out of the director's, officer's or agent's status as such, whether or not the SCHCC would have the power to indemnify the director, officer, or agent against liability under this Article.

ARTICLE X: QUORUM

Section 1. Annual Meeting

The Quorum for the Annual Meeting shall consist of a majority of active member churches present.

Section 2. Board of Directors

The presence of two-thirds (2/3) of the Board of Directors will constitute a quorum.

ARTICLE XI: PARLIAMENTARY PROCEDURES

When questions of Parliamentary Procedures are raised, particularly on issues that are contested, the current edition of Robert's Rules of Order shall be consulted to resolve any impasse.

ARTICLE XII: AMENDMENTS

These Bylaws may be amended by two-thirds (2/3) vote of the delegates of member churches at the Annual Meeting, provided notices of the proposed amendment(s) shall have been given to each member church at least 30 days prior to the Annual Meeting where voting will take place.

OUR KULEANA

- 2) To serve as a channel of communication to the Conference on concerns, questions, and needs of Hawaiian churches.
- 3) To serve as a catalyst for beneficial change that could affect all Hawaiian churches.

WHO WE ARE

The State Council of Hawaiian Congregational Churches (the "State Council") is an affiliate organization of the Hawai'i Conference of the United Church (the "HCUCC" or the "Conference"). It is part of the Conference Council with both voice and vote but receives no operating funds from the HCUCC.

In 1948, a coalition of Hawaiian churches successfully introduced a resolution at the Aha Pae aina that set aside time on the agenda for Kalawina churches to have meetings of their own at which they could voice their mana a. In 1952, this coalition was formally organized as the Council of Hawaiian Churches to provide leadership for Kalawina churches, promote their work, and maintain their great interest in fellowship. Several years later, the Council was re-named the State Council of Hawaiian Congregational Churches. Its' founding purposes continue today.

SOME HISTORICAL NOTES

Over the course of time and history, membership in Hawaiian churches began falling for several reasons; the depopulation of Hawaiians from introduced diseases; the rapid commercial growth of Hawaii in the 1870's; heated political disturbances; and the influx of immigrant labor; By 1900, *Kalawina* churches lost 15,000 members; by 1965 they were down to 2,536 and in danger of falling even further.

The firm of Kramer, Miller & Associates was hired to review the entire conference of UCC churches, to include the unique concerns of the *Kalawina* churches. Its subsequent report in 1968, confirmed that Hawainan churches were on the verge of disappearing if not given consideration and assistance. Impelled by that finding, a Hawaiian Ministry Program, in coordination with the State Council, was established to assist Hawaiian churches toward self awareness and active participation in the total ministry of the HCUCC

The Hawaiian Ministry Program ended in 1992 as the Conference re-shaped itself. In that process Hawaiian culture was acknowledged and confirmed as the host culture for the Congregational Church in Hawai'i and the State Council was recognized as advocate for Hawaiian churches. SCHCC serves as a constant reminder of the Hawaiian presence that first embraced and nurtured the Christian faith in these islands.

FUND FOR REPAIR & MAINTENANCE OF SMALL MEMBERSHIP HAWAIIAN CHURCHES

Application Information

Funding for the Repair & Maintenance of Small Membership Hawaiian Churches is included by the Hawaii Conference Foundation (HCF) in its annual budget. Monies so allocated must be spent within the fiscal year for which it is approved.

The SCHCC has been given the responsibility for administering the funds, but in truth, we must all be partners in seeking the means by which needed repairs can be made. The underlying philosophy of the HCF and SCHCC is to help Hawaiian churches help themselves by sharing in the efforts by church members to raise funds (*i.e.* fundraising, solicitation of gifts, tithing goals, etc.)

More often than not, requests from Hawaiian churches exceed the amount allocated in the budget, not surprisingly, given the age of some of the structures and facilities. The task of reviewing requests and determining which are funded and by what amount, falls to the SCHCC.

In so doing the SCHCC Committee for the Repair & Maintenance of Small Membership Hawaiian Churches (hereinafter referred to as R&M Committee) must take into account a number of considerations including the following:

- The Need for the Project

Is the repair or maintenance critical? How would it affect the mission of the church? What might happen if it were not done? Is it time-critical? Must the work be done within a certain time-frame? What is the church's participation (*i.e.* sharing the cost; providing in-kind services; a combination of both?)

- Priority Consideration

If there are not enough funds to grant all requests, support must first be given to the churches whose deed is held by the HCF. The HCF, as Trustee, has a fiduciary responsibility which carries a legal obligation to support those churches.

In cases where a church that holds its own deed is faced with unusual extenuating circumstances that cannot be addressed because of the preferential obligation imposed by the Trust, SCHCC may suggest an alternative that avoids any conflict.

Applications for the repair and maintenance of septic systems and handicapped accessibility are also priorities of the fund. The first would be in compliance with the Environmental Protection Agency (EPA) and the State Department of Health.

The second would be in compliance with the Americans With Disabilities Act (ADA).

- Scope of Work

The fund is available to cover the cost of the repair and maintenance to existing structures on church premises including the *hale pule* (church building), *hale 'āina* (social/fellowship hall) and *hale ke 'ena* (office building). The scope of work may include the repair and maintenance of windows, doors, floors, and roofs as well as painting, electrical, plumbing and fumigation work.

What the fund does not cover is the cost for sound systems, computer systems, carpeting, air conditioning, fans, appliances and furnishings as well as parking lots, landscaping, gates and fences.

- Reimbursements

Reimbursements for complete projects will not be considered unless, at the discretion of the R&M Committee, compelling and justifiable reasons dictate otherwise.

- Completeness of Application

All applicable items must be completed including the duly-signed minutes of the meetings of both the Member Church and its respective Island Council. The minutes of the meeting of the church's governing body (*i.e.* Congregation, Church Council) must include the type of project the funds are being requested for; the estimated cost of materials, labor and skills to be hired; a clear showing of the total amount to be contributed by the Member Church in cash, in-kind services, or a combination of both and the action taken.

Projects costing more than \$5,000 must be supported by a Licensed Contractor's estimate.

- Discerning Need

Member Churches are encouraged to discern what is needed most. The work of reviewing and acting upon requests for assistance presents the SCHCC, through the work of the R&M Committee, with a challenge and an opportunity to be in partnership with our member churches.

There are no hard and fast rules. There is no checklist.

However, there are guidelines governing the work of the R&M Committee. The R&M Committee seeks to do its work prayerfully and thoughtfully relying upon the Holy Spirit for wisdom and guidance.

Reviewing the Application

1. Member Church forwards the completed Application Form, with the minutes of the meeting of the church's governing body (*i.e.* Congregation, Church Council) approving the submission of the application to the Island Council President.

Please provide the original application plus 2 additional sets of the application (single-sided copies only) and minutes (double-sided recommended).

2. Upon approval by its Island Council, the Island Council President will forward the application form of the Member Church to the Chairperson of the R&M Committee. The Island Council will provide the minutes of the meeting approving the submission of the application to the R&M Committee.

All applications are due by December 31st.

- 1. At the first scheduled meeting of the SCHCC Board of Directors following the December 31st deadline, the R&M Committee shall present its recommendation to the Board.
 - Whether an application is approved or denied, the Chairperson of the R&M Committee will inform the Member Church of the Board's decision by written notice or via email.
- 4. Upon approval by the SCHCC Board of Directors, the Chairperson of the R&M Committee shall inform the Executive Director of the HCF, in writing, of the name of the church and the amount of the approved grants. The Chairperson of the R&M Committee shall provide the HCF with the approved applications and the minutes of the SCHCC Board of Director's meeting in which the approval action was taken.
- 5. Upon completion of its project, the Member Church shall submit a written report to the R&M Committee, preferably with photographs if available. At that time the account will be closed
- 6. Any unused funds shall be returned to the SCHCC. Unused funds may not be applied to other projects.

If new projects are considered, churches must submit a new application.

On June 25, 1990, Reverend Richard W Wong, Pastor Emeritus of Kaumakapili Church, took a bold step to support Hawaiian churches. On that day, he penned a letter to James Richards of the Hawaii Conference Foundation with the intention of establishing an endowment fund to *kōkua* Hawaiian churches. He transferred all his shares of stock from his investment portfolio to establish the *Kahu Richard W Wong Endowment Fund*.

The purpose of this fund is to assist member churches of the State Council of Hawaiian Congregational Churches with educational, missional, evangelistic, personnel, and building needs, from the earned interest income.

Outreach ministries are given priority over building requests. Churches needing repair and maintenance are encouraged to submit applications to the *Repair and Maintenance* of *Small Membership Hawaiian Churches Committee*.

The State Council of Hawaiian Congregational Churches was given the responsibility for the administration of this fund. The President, of the Board of Directors for State Council of Hawaiian Congregational Churches, appoints a chairperson for this committee.

Scholarship Policy

Background: The William Kahuaka'i Keli'iho'omalu Scholarship Fund was launched following the passing of Licentiate Kahu, William K. Keli'iho'omalu. Kahu Keli'iho'omalu served as a member deacon of Kawaiaha'o Church for over 20 years. He enrolled in the Lay Pastors School on the Island of Maui and received his certificate as Licensed Minister for the Tri-Isle Mokupuni. Kahu Keli'iho'omalu served at the Paia Hawaiian Protestant Church for a number of years until his retirement. He moved back to his home on the Island of Hawaii in the village of Kalapana, Puna. Upon his death this scholarship was established by a gift from Mrs. Ada Larrison, a friend of the family. She asked that this gift be placed in a Custodial Account with the Hawaii Conference Foundation in the name of "William Kahuaka'i Keli'iho'omalu Scholarship Fund." Over the years' family, friends, and investments raised that fund to \$5,000. It was her request that the principle of \$5,000 remain in the account and the balance of income received would be used for the purpose of providing scholarship to Lay or Ordained ministers for continuing education. If there are no applicants the unused balance would be re-invested in the same account. The custodians of this Fund will be in the care of the State Council of Hawaiian Congregational Churches, or its predecessors.

I. Who Qualifies?

- A) The applicant must be an active member of a church which is a member of the State Council of Hawaiian Congregational Churches.
- B) The applicant must be enrolled in a Licensed Minister School or an accredited Seminary approved by the Scholarship Committee.

II. How to apply for the scholarship?

- A) The applicant must apply through the local Church of which they are an active member.
- B) Application for the William K. Keli'iho'omalu Scholarship can be acquired from the President of the local Island Councils or through the President of the State Council of Hawaiian Congregational Churches.
- C) The Executive Committee of the State Council of Hawaiian Congregational Churches will review and process all applications on October 15th of each year and forward recommendations to the State Council of Hawaiian Congregational Churches Board of Directors for decision.
- D) When an application has been approved, the awardee will be required to sign a Promissory note.

- III. What are the requirements and stipulations?
 - A) Total Scholarship awarded as follows:
 - 1. Seminary -
 - a) initial 3 years not to exceed \$3,000 per completion of education and not exceed \$250 per semester and \$1,000 per school year.
 - b) development -2 years + not to exceed \$2,000 per completion of education and not to exceed \$1,000 per school year.
 - c) continuing education a sum not to exceed \$1,000 per applicant per three (3) year period.
 - B) The award will be sent to the Seminary or School of Theology by the Treasurer of the State Council of Hawaiian Congregational Churches. In the event that a seminary or School of Theology will not accept the award, it will be sent to the recipient. For Continuing Education recipients, the award will be sent to the applicant.
 - C) The Seminary recipient will be required to send a copy of their transcript for each semester. Continuing Education recipients will be required to send a copy of their expense receipts. Transcripts and expense receipts shall be sent to the:

- D) In the event the applicant does not complete his/her course of study, the award then becomes a loan. The applicant shall repay this loan with no interest attached.
- E) If the applicant is unable to complete his/her course of study, the State Council of Hawaiian Congregational Churches Executive Committee shall be notified immediately. The Executive Committee will then review the individual's situation

and determine whether or not the award becomes a loan.
